Oregon Road Runners Club is a non-profit organization whose mission is to promote running, walking and related activities, for fun, fitness, health and overall quality of life. The organization provides information, conducts events and sponsors activities for both competitive and recreational walkers and runners and "would be" runners and walkers.

The organization conducted multiple runs and walks in 2016 that were open to the general public. The majority of the events were timed. The events ranged in size from approximately 100 to 2,900 participants. The focus of all events was to promote running and walking for fitness, fun, health and overall quality of life.

The organization produced a monthly newsletter that was distributed via email and online, along with a written publication called "The Oregon Distance Runner" that was issued every other month during the year. The online newsletter and printed publication highlighted events available for individual participation, had many health and fitness articles and information, and had articles of interest to runners and walkers concerning running, walking, road racing and general fitness.

The organization conducted weekly training runs that are open for no cost to the general public. The organization also promotes programs that encourage regular running and walking for fitness. The organization gives plaques and other recognition to runners and walkers who participate in events and/or who just complete training and other programs successfully.
