During the year ended December 31, 2016, approximately 300 people participated in our education program.

Community Development/Philanthropy - BUF partners with neighborhood organizations & residents to initiate community problem solving efforts that identify unmet social & economic development needs in Oregon's low income communities. The issues are addressed thru a wide range of collaborative programs that include healthcare, education, economic development & neighborhood revitalization. Thru educational & outreach initiatives, BUF increases awareness to social, economic & cultural significance of philanthropy, builds the capacity of individuals to give & encourage greater philanthropic awareness. During the year ended December 31, 2016, approximately 15,000 people benefited from grants & allocations; 11 agencies received grants.
