This year saw the completion of a multi-year project at the library to revitalize covered space outside the main entrance. Construction was complete in February 2016 and provides more light, library-themed decor, places for people to meet or study, and bicycle parking. The wonderful aspect of the project is that the plaza surface is covered by paving tiles 1 x 4 feet that look like book spines. Donors selected titles of real books, and the pavers show the title, some beautiful graphic design (donated by a local company), the name of the author, and, where a publisher's name would usually show, the name of the donor or honoree. People coming to the library delight in wandering among the tiles and exclaiming over their favorite books or ones they've never heard of. Just inside the front door of the library is a special shelf containing all the books represented by the pavers outside. Embedded lights enhance the surface, especially at night. A total of 220 pavers were purchased and laid.

4b (Code:) (Expenses \$ 10120 including grants of \$ 10120) (Revenue \$ 20985)**BOOK BUDDIES**

This is a new project for the foundation this year, though the library has been running a smaller version of it for a couple of years. During summer months when students don't have access to their school libraries, McMinnville public library is reaching out with its bookmobile to bring books and activities to underserved neighborhoods. The kids stream out of their homes to meet the bookmobile and have a great time, receiving free books, borrowing books, participating in STEAM (science, technology, engineering, arts and math) projects, and keeping their energy up with snacks. The team offering these services comprises both paid library staff and volunteers. Of the total expense shown, a \$10,000 grant from the Oregon Community Foundation covered nearly all. Late in 2016, a special fundraising letter for this program raised nearly \$11,000, which will do much toward funding the program in 2017. Foundation assistance includes covering personnel and supplies costs. The board is considering making Book Buddies part of its annual support for the library, as it does with Collection Enhancement.

Adding to the library's collection of books and other patron materials is central to the Foundation's support. For 2016, the foundation funded the addition of 614 titles.

only affects the valuation shown on the balance sheet.

As explained in the note immediately above, the Foundation changed its method of valuing publicly traded securities. Of the \$92,256 unrealized gain reported on line 5, \$58,791 is attributable to this change of method. The current year increase in market value of investments is the difference of \$33,465 (\$92,256 less 58,791).
