The Gender Justice Program addresses sexism, heterosexism, transgender oppression, reproductive justice, and family security in the context of racial and economic justice. We are BRAVE (Building Reproductive Autonomy and Voices for Equity) works with organizations of color to prevent further weakening of family security and self-determination while being more pro-active in achieving reproductive justice. In 2016 We are BRAVE worked with five organizations based in communities of color to identify policy and culture change opportunities to make steps toward reproductive justice and to break the shame, stigma and silence around reproductive health care access, from conception to birth. Reproductive justice will be realized when all people have the economic, social and political power, and the resources, to make healthy decisions about their own bodies, genders, sexualities, and families -- for both themselves and their own communities. We are BRAVE held its first reproductive justice summit in July, 2017 hosting over 140 individuals representing organizations, health care professionals

Leadership Development is woven throughout all of our programs at the Center. In 2016 we launched our intensive year long leadership program Western Institute of Leadership Development (WILD). The 2016-2017 class constitutes the 13th class the Center has organized. WILD brings together a small group of emerging organizers to build skills to improve their work with community organizations, create shared political analysis on critical issues relevant to movement building, and build a peer community that will support participants into the future and across specific issues, constituencies and states. Our stand-alone leadership development conference AMP (Activists Mobilizing for Power) will return in 2017. The conference is designed for social change organizers and activists from across the country to sharpen skills, expand analysis, and connect with other organizers working for justice.

The Racial Justice Program supports organizations building power in communities of color, immigrant and refugee groups and communities in addressing vital racial justice issues. The program also supports organizational development work to include racial equity. In 2016 the program worked with a wide range of public and private entities to provide language, definitions, organizational assessments and organizational development benchmarks to create more racially inclusive organizations.
