In 2016 Building 39, which is one of the largest buildings in Camp Morning Star, was upgraded to a year-round multi-purpose building. This involved installation of a kitchen, bathroom with showers, and propane water heating and room heating. This accounts for the marked increase in expenses during 2016.
