and long term sustainability The purpose of the corporation is accomplished through public education, research and the advocacy of public policy

toward the goal of building just and sustainable communities that provide for people and the natural world The corporation's purpose and mission is

accomplished through three specific programs: 1. Conservation advocacy for terrestrial, freshwater and marine biodiversity conservation, 2. Public

Lands management for the conservation of native forests and aquatic values of clean water and native salmon, and 3. Public interest research and advocacy

for sustainable private forest management - including increased riparian area protections, the human health impacts of aerial pesticide spraying and timber

production based on long rotations, open and fair markets and increased community economic benefit.

Part III 1 Conservation advocacy for terrestrial, freshwater and marine biodiversity and sustainable community salmon populations The bulk of our work focused

near shore ocean management involving the continued implementation of Oregon's marine reserve system We employ Jim Carlson to fill a coastal staff position.

Jim works in the Cape Falcon and Cascade Head marine reserve areas conducting grassroots organizing and facilitating public education activities

Part III 2 Public lands management for native forests and aquatic conservation values of clean water and native salmon populations Our work in this program

focused on federal forest planning. We completed work assisting the BLM in planning for over 1 million acres of Coast Range forest. Unfortunately, the BLM's

plan came up short of many federal legal requirements. We will continue work that seeks to correct the BLM's plan We also worked to provide the best

available aquatic science to the USDA Forest Service in regards to their upcoming forest planning.

Part III 3 Public interest research and advocacy for sustainable private forest management - including increased riparian area protections, the human health

impacts of aerial pesticide spraying and timber production based on long rotations, open and fair markets and increased community economic benefit. We

continued our support for Mary Scurlock's work with the Oregon Board of Forestry to achieve legally required riparian protections for coastal streams

Additionally, we began an ambitious project researching private forest ownership and taxation
