RURAL ECONOMIC VITALITY - MODELED AFTER SUCCESSFUL PROGRAMS IN THE EASTERN U.S., RDI'S WEALTHWORKS NORTHWEST PROGRAM PROVIDES COACHING AND TECHNICAL ASSISTANCE TO RURAL REGIONS IN OREGON AND IDAHO TO HELP IDENTIFY BUSINESS OPPORTUNITIES. IN 2016, RDI AWARDED WEALTHWORKS BUSINESS INVESTMENT GRANTS TO SMALL BUSINESSES IN OREGON'S SOUTH COAST, NORTH COAST, AND CENTRAL REGIONS. THESE GRANTS WILL HAVE BOTH SHORT- AND LONG-TERM IMPACTS, AND WILL NOT ONLY ALLOW THE INDIVIDUAL BUSINESSES TO EXPAND, BUT WILL CONTRIBUTE TO THE SUCCESS OF THE REGIONAL VALUE CHAINS, INCLUDING JUNIPER HARVESTING AND OREGON'S FISHING AND SEAFOOD INDUSTRIES.
