OHSA's Charitable Checkoff Grant program is funded through the Oregon Charitable Checkoff Commission. The Commission is charged with approving charities to receive donations from taxpayer designated refunds. OHSA offers funding on a grant basis to Head Start programs, primarily for projects relating to safety and health, such as playgrounds, wheelchair ramps, and roof repairs. Money is generally granted in the fall for projects that occur the following Spring and Summer. Programs are prevented from receiving funds two years in a row to ensure more equitable distribution of resources. Funds in 2016 were awarded to Eastern Oregon Head Start, Head Start of Lane County, Kidco Head Start, Klamath Family Head Start, and Neighborhood House. Projects included replacing aging equipment, lead testing and abatement, outdoor play area development, and kitchen upgrades.
