The Ashland Emergency Food Bank provides food, free of charge, to residents of Ashland, Talent and surrounding rural communities. In 2016, we served over 500 households (approximately 1,500 children and adults) each month. Each family receives enough food for breakfast, lunch and dinner for 2-3 days. We provided food for 135,000 meals in 2016. Inventory of donated food items held for distribution are not reflected in the statement of revenue, form 990, part VIII, statement of expenses, form 990, part IX, or on the balance sheet, form 990, part X. Purchased inventory is shown as an expense on form 990, part IX, when purchased.
