28 Project H E R This program continued to provide free comprehensive breast health services (Help, Enlightenment, and Resources) to women in Benton, Linn and Lincoln counties of Oregon The Navigator program, which provides awareness, education and support for women from the time of breast cancer diagnosis through survivorship, consisted of a breast health nurse navigator, a MammaCare specialist, and many breast cancer survivors who mentored patients free of charge with the guidance of the social worker and nurse navigator Project H E R served 265 breast cancer patients in 2016 The MammaCare program's nurses and clinicians taught 6 self-breast exam classes, reaching 155 women in the three area Oregon counties The Cook for Cancer program provided 219 meals, or 855 servings, for families of patients undergoing chemotherapy treatments of all types of cancer diagnoses, oncology and hematology A Project H E R Education Day, titled "Colors of Care An Integrative Approach to a Vibrant Life," was held on November 12th with 245 participants, presentations at the free event included (1) a naturopathic doctor talked about cancer care through naturopathic medicine and acupuncture, (2) a physician cancer survivor shared her experience with breast cancer, and (3) a local hospice service provided a panel of care workers who discussed an integrative approach to caregiving Project H E R nurses and clinicians also participated in other outreach events to increase awareness of breast cancer prevention, including (1) attendance at a Komen for the Cure conference, (2) sponsorship and tabling at the Soroptimist International Walk for the Cause event, (3) attendance at the annual local Soroptimist International tea and auction, and (4) providing support at numerous Pink Out athletic events held at the local university and high schools In addition to \$20,844 of cash expenditures paid for programming (which includes \$200 paid for a MammaCare independent instructor and \$1,000 for grants), \$79,124 of donated supplies, services and facilities were received in 2016 for Project H E R programs (Grants \$ 1,000) If this amount includes foreign grants, check here . . . ► ☐	28a	20,844
