TRANSITIONAL HOUSING IS ALSO PROVIDED FOR AN AVERAGE OF 60 MEN, WHO IN ADDITION TO STAYING CLEAN AND SOBER WHILE IN THE PROGRAM, MUST ALSO VOLUNTEER 6-7 HOURS PER DAY SIX DAYS A WEEK HELPING PREPARE THE MEALS OR WORKING ON THE FARM IN EXCHANGE FOR ROOM AND BOARD. MANY OF THE MEN ARE IN EARLY STAGES OF RECOVERY FROM DRUGS AND ALCOHOL.
