Health Care Access, Economic Security, and Consumer Rights In 2016, BayLegal helped over 8,000 low-income San Francisco Bay Area individuals, seniors, families with children, and disabled people gain access to essential health care and public safety-net programs such as Medicare, Medi-Cal and Food Stamps, and also helped to remove financial impediments to housing, income, healthcare, and economic self-sufficiency for low-income consumers. Through this work, BayLegal secured over \$11,300,000 in quantifiable benefits to help low-income Bay Area residents meet their basic needs and improve their self-sufficiency. (Continued on Schedule O) BayLegal also provides targeted services for vulnerable populations including foster and transition age youth including Commercially Sexually Exploited Children, youth with disabilities, mental health issues, and/or involvement in the dependency or delinquency systems, Veterans, and formerly incarcerated people.

Domestic Violence Prevention In 2016, BayLegal provided integrated, holistic legal services to help over 5,000 low-income San Francisco Bay Area abuse survivors and their children escape domestic violence. BayLegal provides legal assistance with obtaining restraining orders, child custody orders, divorces, and child and spousal support orders. BayLegal also assists sexual assault victims and abused immigrants and their children petition for immigration relief under the Violence Against Women Act. Through this work, BayLegal secured over \$7,480,000 in quantifiable benefits to help violence survivors achieve lasting safety and improve their self-sufficiency.

Housing and Homelessness Prevention In 2016, BayLegal helped over 8,000 low-income San Francisco Bay Area individuals, seniors, families with children, and disabled people prevent homelessness and preserve and expand affordable housing by enforcing housing laws and regulations. BayLegal provided counsel and representation for clients who were victims of illegal evictions, including eviction after foreclosure, discrimination, substandard housing, and other housing rights violations. Through this work, BayLegal secured over \$3,900,000 in quantifiable benefits to help low-income Bay Area residents secure their basic need for safe, affordable and habitable housing.

Often, BayLegal is able to resolve multiple interconnected issues for families to improve their overall self-sufficiency and quality of life. BayLegal impacts the community through extensive outreach and education, technical assistance provided to other community and governmental agencies (in several counties, BayLegal trains workers at housing authorities and social service administration offices on the proper administration of their programs), systemic advocacy and impact litigation. The following client stories provide brief examples of how BayLegal's services change lives.</p> <p>Dory is known throughout her tight-knit community for her many acts of kindness and generosity, like balancing checkbooks for her neighbors and opening her home to her recently-divorced daughter. After moving in, Dory's daughter invited her own adult daughter and grandchildren to live in the house, causing Dory to often be confined to her bedroom. When she requested that her granddaughter and great-grandchildren move out, Dory was met with outright refusal and verbal assault. Eventually, the abuse turned physical and escalated to the point where Dory had to crawl to her neighbor's house to call the police. County Adult Protective Services referred Dory to Bay Area Legal Aid (BayLegal), where attorneys sought an eviction and permanent restraining order against Dory's daughter and grandchildren. At first, the judge allowed her daughter to stay in the home as long as she kept away from Dory. This arrangement still caused Dory to fear for her safety to the point where it was causing a dangerous rise in blood pressure. BayLegal attorneys persisted, returning to court on two more occasions and winning a permanent order for the family to leave the home and stay away. Dory now lives happily and safely on her own. She has a strong community of neighbors as well as a nephew who loves and supports her. Her kind and generous spirit persists through the trauma she has faced. ----- "I was in a very dark place," Yan recalls of her first visit to Bay Area Legal Aid. Yan's abusive ex had not only attacked her, but also hurt her one-year-old child, and her elderly mother. Yan had filed a temporary restraining order, but she was unable to afford an attorney and was left unrepresented in court. Living in fear for her family's continued safety, Yan felt she had nowhere to turn. China's strict family-planning laws which impose steep fines on single mothers, in addition to the social stigmatism, made returning to her home country impossible. Her lawyer not only provided legal help in securing a Domestic Violence restraining order and primary physical custody of her child, but also emotional support to overcome her isolation and fear. ----- For low-wage restaurant workers, missed hours and paychecks mean not being able to buy food or pay rent. After the birth of her third child, Chen was fired because she could not nurse and keep up with her restaurant's demanding shifts. She soon exhausted her unemployment benefits and was not eligible for CalWORKS, a benefit program providing cash assistance to low-income families. When her husband lost his job as well, the family of five was in real danger of becoming homeless. Chen turned to Bay Area Legal Aid for help, where she was connected to both a Mandarin interpreter and an attorney with expertise in general assistance and other benefit programs for low-income families. With help from her interpreter and attorney, Chen applied for emergency assistance funds so her family could afford rent, food, and other necessities while she and her husband found work again. BayLegal also balances its direct individual services with systemic work to address root causes of issues harming low-income residents. Low-income people do not have the time or expertise necessary to address systemic errors and inefficiencies that develop in under-resourced government agencies, or to challenge unlawful activities present in consumer, housing and healthcare markets. By working with thousands of individuals and families each year, BayLegal has intimate knowledge of the problems that cause poor people harm and impede their struggle for self-sufficiency. Systemic work, informed by BayLegal's work with individual clients, includes impact litigation, legislative and administrative advocacy, and training, technical assistance and policy development for agencies that administer housing, healthcare and benefits programs for the Bay Area's low income residents. BayLegal's work is a vital part of the poverty eradication movement. Recent studies have confirmed that investing in legal services is a cost effective means of solving issues faced by low-income people. "The impact of legal aid in terms of public costs saved - homelessness prevented, health benefits secured, domestic violence harms averted, among other measures - has been documented in dozens of local and national analyses," says David Udell, director, National Center for Access to Justice at Cardozo Law School in New York City. "The impact in terms of people's lives is immeasurable." As more communities and municipalities learn about the value of civil legal services in stabilizing the lives of low-income people, BayLegal has experienced a demand for legal services across its seven county service region. While BayLegal continues to strategically develop its program to ensure it is responsive to the ongoing and emerging needs of the diverse populations it serves.</p> |
