 Litigation Program ALDF's Litigation program file cutting-edge lawsuits to end the abuse of animals, including companion animals, wildlife, and those abused in industries like factory farming, laboratories, and the entertainment industry. Our litigation effort promote recognition of the bonds between human and nonhuman animals with an eye toward securing strong and lasting protections under the law. From filing as plaintiffs or representing other organizations and individuals, to filing formal complaints against government agencies, to advocating for legislative changes to protect animals, the Litigation Program makes a substantial impact on the lives of individual animals and the entire field of animal law.

 ALDF Grants and Scholarship Programs As part of ALDF's Animal Law Program, ALDF makes grants available to various organizations, law centers, individuals and student chapters of ALDF at law schools across the country and in Canada to support the efforts to inform, educate, and take action for animal protection laws. ALDF grants are critical to encouraging the next generation of animal lawyers. Amount of grants and scholarships funded during the year ended December 31, 2016 amounted to \$660,996, which included various payments to law schools, organizations, and individuals.

 Criminal Justice Program Through our Criminal Justice Program, ALDF is able to increase prosecution and conviction rates for animal cruelty. The program provides critical resources to prosecutors and enforcement agencies. By offering free assistance, the program ensures that state criminal anti-cruelty statutes are vigorously enforced and that those convicted of abuse, cruelty, and neglect receive appropriate sentences. The Criminal Justice Program also works with state legislators to enact felony anti-cruelty statutes in states that do not yet have them and to upgrade existing laws in states that do. The Criminal Justice Program also serves prosecutors, legislators, researchers and the public interest with a nationwide database of cruelty cases as well as current and model animal protection laws.
