Clinical operations provided care for 2,461 families last year during an emotional time in their lives as they suffered the loss of their loved ones. Families were either informed of their loved one's donation decision made on the state donor registry or authorized donation for their loved one. Through their generosity, thousands of others were saved or healed because of these gifts of life. In 2016, we recovered 959 organs for transplantation from 291 organ donors and provided tissues for transplantation from 2,311 tissue donors, an estimated 90,598 lives were improved as a result.

Form 990, Part III, Line 4b:

Donor families are cared for throughout the donation process and following the donation. Our professional staff provides support and information in the moment and provides aftercare resources and support to donor families for a year post-donation. Three separate donor family gatherings honored and celebrated the donor families and their loved ones who gave the gift of life through organ and tissue donation. Donor family gatherings were held in Pleasanton, Reno and Fresno on three separate days to accommodate nearly 2,500 families whose loved ones became donors in 2016.

Form 990, Part III, Line 4c:

The shortage of available organs and tissues is a serious issue as 22 people nationally will die each day waiting for an organ transplant. Public education efforts are focused on increasing registrations on the state authorized donor registries in California and Nevada along with the newly created Donate Life America national registry. In 2016, added 461,695 new names to the registries in our service area through a variety of efforts. In 2016, the Community Education department focused on several key campaigns to increase donor registrations. These campaigns included working with community Health Clinics, high schools, faith organizations, Consulate offices, civic groups and focusing on multicultural outreach. We partner with our Department of Motor Vehicle offices to provide information and develop relationships with each office to ensure the recording of the donation decisions of millions of Californian's and Nevadan's. Most donor registrations occur at the DMV offices and through the Adopt-A-DMV program, our staff and volunteers regularly visit, educate and provide point-of-transaction reminders to the public. We successfully reached many multicultural community clinics with information and in-services, worked with high school teachers to integrate organ and tissue donation information in health/science curriculums and engaged faith leaders in growing support for donation in their congregations. We documented 400+ proactive free media stories that were seen across the country. The results 54% of our organ donors were on the state donor registries.

Action for conflicts varies from simple disclosure to directed action. Where a potential conflict of interest exists, it shall be the responsibility of the person involved or any other person with knowledge to notify the Board of Trustees of the circumstances resulting in the potential conflict so that the Board of Trustees can provide such guidance and take such action as it shall deem appropriate. No trustee who directly or indirectly is involved in a potential conflict is considered, nor shall the trustee vote on any action of the Board regarding that potential conflict.
