Organizations rated the services a 3.65 on a 4 point scale and 97% of clients would work with 501 Commons again. Last year we picked up the board training series formerly sponsored by United Way of King County, became the Encore Fellows Program sponsor in Washington and Idaho, and expanded our support for our Salesforce users by offering Salesforce Administration.

Our Human Resources program is growing rapidly. In 2016, we worked on 60 projects, including ongoing services for HR partners and HR Toolkit, offered in Walla Walla, for 6 organizations. Over 850 people participated in training and peer learning sessions, as well as various cohort learning sessions. Use of our website grew by 15% again with 113,000 sessions and nearly 76,000 users. Resource Directory pages were the most popular destination. The Information and Referral Program handled 440 cases, helping people find service providers and resources, solve problems, and determine their best course of action.
