Public education campaigns - Since FUTURES launched the very first national domestic violence public service campaign, "There's No Excuse" in 1994, we have launched countless efforts to build the public's capacity to respond to and prevent violence, including specialized audiences such as educators, teenagers, and athletic coaches. We created the only evidence-based curriculum program endorsed by the CDC designed to train and motivate coaches to teach their young male athletes healthy relationship skills, Coaching Boys Into Men. FUTURES also launched That's Not Cool in partnership with the Department of Justice's Office on Violence Against Women to empower teens to prevent digital dating abuse in their schools. With over 800 Teen Ambassadors engaged across the country, hundreds of partner organizations, and schools using That's Not Cool materials, the award-winning web site reaches over 1.2 million teens per year. Also in partnership with the Department of Justice, Futures Without Violence launched Changing Minds at the White House in October 2016. This national campaign calls attention to the impact that childhood trauma has on the developing brain, and motivates adults who interact with kids to engage using healing gestures that can help a child thrive.

Form 990, Part III, Line 4b:

Children/youth/young families - FUTURES is a nationally recognized leader in preventing and addressing childhood exposure to violence and trauma. In 2016, we provided education to over 7,500 people through our virtual and in-person trainings and distributed 6,000 educational downloadable materials. Through three of our signature programs, School Success Leadership Exchange, Changing the Narrative on Sexual Assault and Changing Minds Leadership Institute, we trained 19 diverse school districts in Oregon, Tennessee, Georgia, Massachusetts, and California. In addition, we educated thousands more in Maine, North Dakota, Puerto Rico and Indiana. We educated administrators, nurses, teachers, advocates, early childhood providers, law enforcement, and many others on the impacts of childhood trauma, bullying and sexual assault and how to increase academic achievement in school. Our work continues to advance promising practices that help young people heal and thrive. FUTURES serves as the lead organization for the Department of Health and Human Services, Administration for Children and Families, Children's Bureau - new Quality Improvement Center on Domestic Violence in the Child Welfare system. This Center will be a five-year effort to advance research and evidence on how best to serve families that experience domestic violence and are involved in the child welfare system.

Form 990, Part III, Line 4c:

Health - As the National Health Resource Center on Domestic Violence (HRC) since 1993, FUTURES has been a leader in healthcare issues related to domestic violence. In 2016, we provided direct training to 10,137 professionals and led or attended over 95 meetings, workshops, webinars, or conferences. Additionally, HRC staff responded to more than 4,870 technical assistance requests, conducted 30 site visits, and disseminated over a million materials. Two new websites were developed--- <http://www.ipvhealth.org> and www.ipvhealthpartners.org designed to be digital hubs for establishing partnerships between domestic violence agencies and healthcare settings across the country. Our 8th biennial National Conference on Health and Domestic Violence will be held September 26-28, 2017 in San Francisco, CA. The conference co-sponsors are some of the most influential health organizations and federal agencies in the country including the American Medical Association, American Academy of Pediatrics, American Academy of Nursing, American Public Health Association and Centers for Disease Control and Prevention.
