

**Formed to identify, educate, network and encourage Catholic clergy to teach and preach effectively about the defense of human life from abortion and euthanasia, in the context of a consistent ethic of life, and to educate lay people on these issues, and work in an interdenominational context.**

**Education of Clergy - Through the travels of its pastoral team to visit parishes and present seminars, through media broadcasts and publications and through regular one-on-one consultation given to priests around the world, the Priests for Life, Inc. pastoral team continued to educate and equip priests, deacons and seminarians to effectively proclaim the pro-life message and compassionately counsel those tempted to have abortions and bring healing and forgiveness to those who have already had abortions. In particular, the liturgical resources and homily hints, in English and Spanish, continue to be provided in print, on YouTube channels, and through a smartphone app. In April 2016, a well-known Catholic publisher released Fr. Frank Pavone's latest book about preaching on abortion ("Proclaiming the Message of Life.") Along with providing an overview about preaching on abortion based on the extensive experience of the Priests For Life team since 1991, the book includes the most frequently asked questions and concerns of clergy regarding preaching on this topic, as well as notes for homily suggestions, drawing from each set of Sunday readings for the entire three-year Sunday cycle of the lectionary. We also launched the Cardinal John O'Connor Institute for the Pro-life Training of the Clergy, which include a re-packaging of many of the activities Priests for Life has done all along, together with some new initiatives including seminars, retreats, days of recollection and specialized training in post-abortion healing.**

**The Elections of 2016 - Priests for Life conducted a wide range of activities to educate voters on prolife issues. These activities included mass distribution of our non-partisan comparison piece of the party platforms, voter training of clergy, extensive television, radio, and internet broadcasts. We continued to raise awareness about the freedom that the church has under the law to preach, teach and "pass moral judgment even in matters relating to politics" (Second Vatican Council, Gaudium et Spes, n.76). This does not mean becoming partisan, but rather applying the pro-life teaching of the church to the political arena, according to the teaching of the US Bishops' document Living the Gospel of Life (1998). We assist Churches and pro-life organizations to initiate partisan or violating the law, but rather applying the pro-life teaching of the church to the political arena, according to the teaching of non-partisan voter registration drives, voter education and get-out-the-vote activities.**

**International Outreach - In 2016 Priests For Life continued its participation at the United Nations as a Non-Governmental Organization in special consultative status with the Economic and Social Council by submitting statements and participating in key conferences such as the Commission of the Status of Women, Commission on Social Development and the Commission on Population and Development. Priests for Life also continued to focus on promoting our pro-life work with various Vatican dicasteries, the United Nations, and many countries around the world. We attended the annual conference at the Academy for Life, and meetings at the Council for the Family, New Evangelization, and Justice. We participated in a number of meetings and events hosted by the Mission to United Nations including: Path to Peace, Ending Modern Slavery, Defending religious freedom & other human rights, Prayer Service marking the opening of the new UN Session and Secretary of State luncheon meeting. We also attended the Mission to Organization for Security and Cooperation in Europe as well as the International Catholic Legislators Network conference and participated in the Canonization of Saint Mother Teresa. We met with various pro-life leaders from Austria, Ghana, Argentina and China where we were able to assist in expanding their pro-life work and assist in translating our literature.**

**1- Priests for Life Case Against HHS Mandate - Priests for Life was the fourth group to launch a federal lawsuit against the "HHS Mandate," which was an attack on religious liberty whereby the former presidential administration attempted to force religious groups to be complicit in the expansion of abortion and contraception. On November 6, 2015, the Supreme Court granted review to our case, along with six other cases challenging the mandate. In May of 2016, the Court, having heard from both sides that there may be a way to work out the dispute without burdening the religious liberty of the petitioners, sent the case back to the lower courts with the instructions that the government and the petitioners were to attempt to work out a solution. Priests for Life has been participating in such discussions, and when the government opened up a public comment period, Priests for Life led the way in getting Churches, professionals, and the general public to weigh in on the matter.**

**2- Select Panel on Infant Lives - Priests for Life promoted, supported, and assisted the work of the Select Investigative Panel on Infant Lives, a special panel of the US House of Representatives which is investigating the abortion industry in the United States for potential violations of federal law. Our priests associates assisted in gathering information that went to the panel and resulted in action to further investigate late term abortion activities.**

**3- ExposeAbortion.com - Priests for Life has expanded its efforts to expose the reality of abortion. On the website ExposeAbortion.com, on Facebook.com/ExposeAbortion, and on the Twitter account @ExposeAbortion, one quote per day is provided from abortionists, from from medical texts, from court testimony, from those who have had abortions, and from other sources that reveal the damage abortion does to the babies their mothers. This site is now being expanded to include the information Priests for Life has gathered from within the abortion industry and from other sources, exposing the abortion procedure, the damage it does, and the corruption within the abortion industry.**

**4 - Media - In 2016, Priests for Life taped four new 13-part television series for EWTN. Two new seasons of Defending Life were taped and another two new seasons of The Catholic View for Women. Our internet program, "Pro-life Straight Talk," as well as daily broadcasts by Fr.**

**5- Prayer campaigns - We continue our campaign to mobilize believers to pray each day for an end to abortion. **7- Unborn Child Protection from Dismemberment Abortion Act - Priests for Life provided strong educational support for the Unborn Child Protection from Dismemberment Abortion Act, which continues to advance on the state level and will eventually be introduced on the Federal level. This measure protects unborn children from any and all procedures involving dismemberment.**

**8- "Have You Seen It?" - At Priests for Life we continue to be convinced that America will not reject abortion until America sees abortion. Therefore, we have developed educational resources that show what abortion does to a child, and initiated grassroots campaigns by which people can challenge one another, on a one-on-one basis and in social media, with the question, "Have you seen it?", urging them to look at the reality of what abortion is before forming an opinion as to whether it should be legal or not.**

**10- Reversal of RU-486 - The abortion technique of RU-486 involves taking two distinct drugs separated by a short period of time. The circumstance arises regularly that mothers take the first drug and then change their mind about aborting their child prior to taking the second drug. One of our medical advisors at Priests for Life, Dr. Matt Harrison, pioneered the technique of using progesterone to reverse the effects of the first drug in the RU-486 combination and save the life of the child. Since then he has collaborated with another one of our medical advisors, Dr. George Delgado, who has formed the "Abortion Pill Reversal" network, enabling other physicians to use this protocol. This protocol has been developed, and a medical kit now made available to physicians to reverse the deadly effects of this abortion procedure. Priests for Life continues to collaborate with these physicians to educate both the public and the medical profession about this and to spread the word about this to physicians, pregnancy centers, Churches, pro-life groups and the general public. **11- Healing the Shockwaves of Abortion - Throughout 2016, Priests for Life, through its Silent No More Awareness Campaign (a joint project project with Anglicans for Life) continued its campaign called Healing the Shockwaves of Abortion. It promotes educational and pastoral based on the fact that every abortion impacts multiple groups of people: not only baby and parents, but also grandparents, siblings, friends, abortion providers, pro-life advocates, and our entire society. Since the wound is multifaceted, so is the healing. Each month we focused on a special target group that has been directly impacted by abortion loss, with helpful information, resources, and abortion-recovery programs. Through a variety of educational and media efforts, Alveda King continues to proclaim that the civil rights movement of today is the pro-life movement, and that the dream of her uncle Martin cannot survive if we murder our children. Ms. King took 73 trips that brought her to 16 states as well as Canada and Mexico. She attended events surrounding the observance of Martin Luther King Day, as well as the Walk for Life and StandUp4Life marches in California. She attended the Women Speak for Themselves Rally in front of the US. Supreme Court while the Court heard oral arguments in Priests for Life and others' case against the HHS Mandate. **13- Parliamentary Network for Critical Issues - In 2016, PNCI continued to share global and regional news and information related to life life issues and collaboration with parliamentarians, staff, clergy and pro-life NGOs in the U.S., Europe, Africa and Latin America and at the United Nations. Our representative for Priests for Life to the United Nations helped to ensure that Priests for Life used its UN NGO status to promote respect for the right to life and human dignity for all, from conception to natural death. PNCI's newsletter and updates were a recognized source for global pro-life news and regularly reposted on websites including LifeNews and National Right to Life News.**

**14- Youth Outreach - In 2016, our Youth Outreach leader, organized and emceed the annual Youth Rally at the March For Life in January. He then went onto the Walk for Life in San Francisco, had a booth at the Students for Life conference and at the Conversation for Life in Oakland where he was a speaker. He also helped organize Protest Planned Parenthood rallies in Washington DC and Dayton, Ohio. He also headed our summer intern program where we had five full-time interns who were immersed in pro-life activism, and interaction with key national leaders. Many of our interns end up devoting themselves full-time to key positions in the pro-life and pro-family movements.**

**15- Pro-life Day of Silent Solidarity - Our Youth Outreach, under the direction of Bryan Kemper, conducts each year, on the third Tuesday of October, the "Pro-life Day of Silent Solidarity," on which students commit to be totally silent all day as a sign of their solidarity with children children in the womb. When someone attempts to speak with them, they hand them a flyer explaining abortion and the reason they are silent. Many lives have been saved as a result of this project.**

**16-Rachel's Vineyard - The ministry of Rachel's Vineyard continues to be the largest pro-life outreach around the world for healing after abortion. It operates with the assistance of Priests for Life, Inc. and utilizes a retreat model based in Scripture and the sacraments.**
