Public programs take place in venues located in all regions of the state, and are run in partnership with local arts & cultural organizations, historical societies and museums, chambers of commerce, Lions' Clubs, Washington State Parks, and other community-based groups. Audiences range from 10 people for a hands-on craft workshop, to 100 - 200 for a performance in a small venue, to thousands for a festival setting or one of our publications or radio or TV broadcasts. We have made a special effort to outreach to rural and under-served communities in Washington, and we both document and present many different ethnic and occupational artists and tradition bearers who represent a wide range of cultural communities.
