Oakland ProgramAPEN's Oakland staff and local members led the grassroots campaign to educate decision makers and the public about the need to stop the transport and storage of coal in Oakland. Our members connected with local allies and together led the campaign for tenant protections in Oakland - we continued our struggle against gentrification and displacement of low-income families. We maintained our role as a member of the Community Choice Aggregation for the East Bay and advocated for equity in energy. We integrated local voter mobilization and grassroots organizing and put on the annual APEN Academy. The Academy educated local members about public speaking, conducting campaign analyses, and multi-racial alliance building.

Form 990, Part III, Line 4b:

Civic Engagement APEN's state team ran a robust and integrated voter contact program throughout 2016 - contacting more than 50,000 voters statewide via email, mail, phone, and in-person conversations. Outreach was conducted in 7 different languages. We put on several nonpartisan voter education forums in the cities of Oakland and Richmond. APEN partnered with allies and funders to conduct research on API voter behavior and civic engagement best practices.

Richmond Program APEN's Richmond program staff planned and put on the 3rd annual "Our Power Festival" and brought together local community members, allies, and sustainable businesses. We strengthened our youth program and put on the 2nd APEN Academy for Youth. Our student leaders participated in nonpartisan voter outreach and put on a nonpartisan Candidates Forum. With our allies we formed Cooperation Richmond - a cooperative incubator for local entrepreneurs and loan fund. APEN and our local members and allies continued to educate local regulators about the need to decrease harmful emissions from the local refinery.
