National program expenditures funded our national campaigns and programs, from organizational support for state affiliates, to policy advocacy, to national educational campaigns. A few highlights were our national conference of state affiliates in Washington D C, our support of the EPAs Clean Power Plan, and Faith Climate Action Week which activated 1700 congregations to preach or teach about climate change and the moral imperative to care for Creation. In 2016 IPL earned over 1,000 news media mentions and increased our social media presence as well. We regularly communicated with over 84,000 people on our email list and 18,000 congregations.

The next largest portion of our program expenses was distributed in support to state affiliates. State IPLs educated their congregations about global warming and advocated for clean energy alternatives to coal, supported renewable energy incentives, fuel standards, and new EPA climate standards for power plants.

California Interfaith Power & Light (CIPL) educated its 680 member congregations about global warming and advocated for equitable and effective climate policies at the state level. Highlights of the year included a "Cool Climate Awards" event honoring congregations for greening their facilities and engaging their communities in climate solutions and a diverse Green Jobs Summit in Oakland. The summit was attended by over 80 policy makers, faith leaders, clean energy companies, social justice advocates, investors, and public agencies such as transit and water districts and helped galvanize a shared vision for an inclusive and sustainable green economy in the East Bay.
