In 2016, Yggdrasil continued to receive significant gifts of land and well as financial gifts to support its mission At the end of 2016, total acres owned was 1391 44, plus 110 acres of agricultural easement In addition to the new properties, Yggdrasil expended funds to remediate its properties in order to prepare them to be lease-worthy This work included work on barns, roofs on housing and the repair and restoration of property boundary fencing The Wisconsin dairy property is now fully leased and productive Yggdrasil also procured a major gift of cash which will serve as a long-term reserve fund
