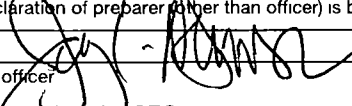

Network of Ethnic Physician Organizations (NEPO): NEPO brings together more than 50 ethnic physician organizations from across California to create an empowered, unified voice of ethnic physicians and their organizations to promote diversity, access, and quality, in healthcare. NEPO is designed to identify strategies for building the capacity of Ethnic Physician Organizations, address health disparities and the social determinants of health, improve workforce diversity, engage in leadership development and to encourage physicians and other providers to be community advocates. NEPO hosts an annual Summit which brings together nationally recognized policy leaders, elected officials and physician leaders. This successful Summit draws over 250 physicians, other providers, and policy experts to learn best practices, share information, and network. The event is frequently cited as a "not to miss" policy Summit for all physicians who serve underserved communities.

4b (Code:) (Expenses \$ 57,802 including grants of \$ 0) (Revenue \$ 0)

Pneumococcal Vaccine Improvement: The overall goal was to address local obstacles that limit eligible adult patients from receiving pneumococcal vaccination among communities of color and the providers that serve them, thus increasing the number of Los Angeles County residents who are vaccinated. The long-term goal was to improve the health and well-being of communities of color and reduce healthcare costs. The CMA Foundation addressed these obstacles by working with physician practices serving communities of color and low-income populations in Los Angeles County to participate in a 9-month project to increase adult pneumococcal immunizations by at least 12% in their practices. The CMA Foundation tracked adult pneumococcal vaccination rate data using the practice's electronic health record (EHR) to compare baseline data to final data at the end of the project. The CMA hosted in-person training sessions, conducted coaching sessions and performed site visits to educate participants about new practice protocols and tools to help practices increase pneumococcal vaccination rates.

Alliance Working for Antibiotic Resistance Education (AWARE) Project: For over 20 years, AWARE has been a national leader in addressing antibiotic resistance and appropriate antibiotic prescribing. The AWARE expert clinical workgroup convenes to develop timely educational materials, commonly known as the "AWARE Toolkit," which promote the appropriate use of antibiotics in English and Spanish. AWARE launched the AWARE Toolkit mobile app to provide easy access to the project's Adult and Pediatric Acute Respiratory Tract Infection Guidelines, which has been downloaded by thousands of providers in countries across the world. The AWARE Project was cited as a Best Practice on appropriate treatment for children with viral upper respiratory tract infections by the California Department of Health Care Services. The AWARE Project's Clinical Toolkit is utilized in 15 other states across the nation and is featured on the American Medical Association's website.

Schedule D, Part V, Line 4 - Medical Student Fund - In 1983, a donor established the Medical Student Fund with CMA Foundation. Principal contributions of \$110,811 are to remain intact as a permanently restricted endowment and only the amounts earned as interest income may be expended by CMA Foundation for medical student grants. CMA Foundation Endowment - This general endowment is comprised of several different endowment contributions made to CMA Foundation. The Audio Digest Foundation established the endowment by contributing \$200,500 to CMA Foundation in 1989. The contributions are to remain intact as a permanent endowment; only amounts earned on investments may be expended by the Foundation. During 2004, the Foundation encouraged physicians to donate settlement checks to which they were entitled from a lawsuit brought against CIGNA. The solicitation indicated that all funds donated would become part of the CMA Foundation Endowment Fund. Contributions totaled \$285,784. The principal of this endowment must remain intact and only the investment earnings may be expended by the Foundation. During 2009, the Foundation received \$12,061 of other contributions with permanent restrictions. During 2014 and 2015, the Foundation received a \$10,000 contribution from Blue Shield to be held as an endowment. The investment earnings on these funds may be expended by the Foundation. The total restricted value of these contributions is \$518,345. In addition - The Foundation Board of Directors established the CMA Foundation board designated endowment to be used at their discretion.

Schedule D, Part X, Line 2 - The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires the Foundation to report information regarding its exposure to various tax positions taken by the Foundation. The Foundation has determined whether any tax positions have met the recognition threshold and have measured the exposure to those tax positions. Management believes that the Foundation has adequately addressed all relevant tax positions and that there are no unrecorded tax liabilities. Federal and state tax authorities generally have the right to examine and audit the previous three years of tax returns filed. Any interest or penalties assessed to the Foundation are recorded in operating expenses. No interest or penalties from federal or state tax authorities were recorded in the accompanying financial statements.

Form 990, Part III, Line 1 - Through NEPO, the CMA Foundation has focused on health disparities, social determinants of health and engaging physicians as community advocates. In addition, the CMA Foundation and NEPO host the annual Building Healthy Communities Summit. The CMA Foundation is far reaching, as it is able to reach over 40,000 physicians through a partnership with CMA and the 20,000 ethnic physicians represented by NEPO member organizations who collectively provide medical services to the majority of patients across California. In addition, the CMA Foundation has effectively worked with nurse practitioners, pharmacists, physician's assistants, podiatrists and other health care providers on public health and quality improvement projects. In addition, the CMA Foundation is supporting the next generation of physician community leaders through the Medical Student Community Leadership Grant Program which provides grants to California medical student organizations to support innovative health-related programs.

Form 990, Part III, Line 2 - 1. Advance Care Planning Focus Groups. The CMA Foundation recruited ethnic physicians who serve a significant number of Medicare patients to attend focus groups on advance care planning. The goal of the focus groups was to hear from ethnic physicians about the barriers and/or motivations to have conversations surrounding advance care planning with patients. 2. Diversity in Clinical Trials. This project is aimed to increase awareness about clinical trials in diverse communities and to increase the diversity of clinical trial participants in California. The CMA Foundation created office posters for both providers and patients, and a public service announcement which included guidance about where to find information on current clinical trials and what to expect in a clinical trial. The information was distributed to physicians and stakeholders through the CMA Foundation's communication channels, including the Network of Ethnic Physician Organizations (NEPO). 3. Prevent Diabetes STAT. The CMA Foundation engaged in efforts to promote the Prevent Diabetes STAT. Screen, Test, Act-Today California initiative to physicians across California. The CMA Foundation provided outreach and education to CMA Foundation and NEPO physicians to raise awareness about prediabetes and the diabetes prevention program. The CMA Foundation also hosted CME-certified sessions and hosted a provider focus group to present on the topic of the Prevent Diabetes STAT initiative. 4. Pneumococcal Vaccine Improvement. The CMA Foundation was 1 of 3 organizations nationally to be awarded funds for a project to improve the rate of adult pneumococcal immunization. The project was aimed to improve pneumococcal vaccination rates by at least 12 percent among ethnic minority and low income adult populations in Los Angeles County. The CMA Foundation hosted live learning sessions, performed site visits and held coaching calls in order to educate participants about new practice protocols and to monitor the progress of each practice.

Form 990, Part III, Line 3 - The CMA Foundation ceased conducting the Adult Vaccine Awareness Campaign. This project was aimed to increase adult vaccination rates in California by improving adult vaccination awareness. The CMA Foundation developed public service announcement (PSA) videos in both Spanish and English and also distributed the PSA videos to local television and radio stations. The CMA Foundation also tracked distribution and demographics of the viewing audience. The CMA Foundation also ceased conducting the Medi-Cal Coordinated Care Physician Focus Groups. The CMA Foundation identified and convened physician focus groups to better understand what physicians know about the Coordinated Care Initiative (CCI), as well as their questions and concerns about CCI. The CMA Foundation conducted the focus groups in counties in the CCI pilot program in conjunction with the Network of Ethnic Physician Organizations (NEPO).

Form 990, Part V, Line 2a - CMA Foundation uses a Professional Employer Organization (PEO), TriNet (48-1304650), to administer its payroll, health benefits, and human resources. As such, CMAF does not file a form W-3 as this is handled by the PEO. The number provided on this line is the total number of employees that were included at any point during 2016 in this PEO agreement.
