 At the press of the medical alert button, the Lifeline 24-hour emergency response team is activated. Lifeline saves lives in the event of an emergency, reduces suffering and fear, and provides for early intervention in the event of a fall. There are greater than 700 clients currently receiving Lifeline services. The Service League started a financial assistance program that offers the service at a reduced fee. Our financial assistance program is currently providing financial assistance for approximately 65 clients who otherwise could not afford the service. The Service League recognizes their social responsibility to address the needs of the at-risk elderly and disabled members of our community, and those with limited financial resources.

 To support the Salinas Valley Memorial Hospital Foundation with expansion and improvement of hospital facilities. To support the SVMH Foundation programs such as the Childrens Miracle Network. The Service League President will immediately be given the request and will be the responsible party for responding to the request. Requests for review of documents will be acknowledged within five working days of receipt of the request. The President will send a written reply to the person filing the request, including copies of the requested documents, Service League financial statements from the most recent year end, and the Conflict of Interest Policy, with Schedule B of the Form 990 omitted to protect the privacy of the names of individual donors. The President will give a copy of the written reply, along with the copies of the documents, to the Director of Volunteer Services, who will retain a copy in the compliance file.
