Through these collaborative efforts, they improve access to health care and provide health education resources in the surrounding communities. During 2016, some of the larger grants paid to the three medical centers were used for the Welcome Baby Program at Holy Cross (\$1,333,476), emergency department campaign and upgrades at Saint Joseph (\$1,015,687), and new tomosynthesis mammography equipment at Saint Joseph (\$921,962).

The Foundation makes direct payments to several community benefit organizations each year. Some of the larger contributions made during 2016 were to the All Inclusive Community Health Center (\$40,000), Alliance for Housing and Healing (\$25,000), Family Promise of the Verdugos (\$25,000), Family Service Agency of Burbank (\$25,000) and the Kids Community Dental Clinic of Burbank (\$25,000)

Nursing scholarships are provided to support additional education and training for nurses. During 2016, 10 scholarships were awarded, totaling \$27,868. In addition, the Foundation supports clinics that provide medical services for those who are unable to pay for the services. Smaller grants to outside organizations are approved based on applications received and are also monitored by the Mother Joseph Fund, which is a community outreach initiative under the direction of the California Region Mission Integration Officer and a committee comprised of community ministry board members and mission leaders. Nursing Scholarships - nurses apply for scholarships, and proof of enrollment in a qualified course, the fee amount, and benefit eligibility are verified. The scholarships available are allocated and distributed to the applicants upon approval. Access to Care individuals are referred to the program either from the Emergency Department at Providence St. Joseph Medical Center or from an All-Inclusive Community Health Center. These individuals are uninsured, ineligible for Medi-Cal and in need of a specific type of specialty care consultation, including podiatry, urology, ophthalmology, orthopedics, gastroenterology, ENT or cardiology. Patient visits are limited to 1-4 visits. This allows for a clinical interpretation of the medical issue and then the patient is referred back to the originating clinic.

The Board retains an independent consultant each year to review salaries of those in the most significant leadership roles in the organization. Part of the consultant's role is to review an extensive array of compensation surveys of large, not-for-profit health care systems in the United States. Providence is one of the larger health systems in the country, and as such, the Board benchmarks executive compensation against other large, not-for-profit health systems whose revenue is similar to that of Providence. Additionally, Providence's labor market continues to spread across health care and into general industry. Because of this, Providence also takes into consideration general industry for-profit market data, where applicable. Base salaries for Providence executives are generally targeted to the median level of the market, as identified by the independent consultant and reviewed with the Executive Compensation Committee. Performance incentives allow executives to earn additional compensation if they achieve specific organizational goals for furthering Providence operating commitments and strategic objectives. The Board of Directors conducts a thorough process to ensure performance incentives are aligned with appropriate market practices. The Board's process for executive compensation fully complies with IRS standards and mirrors best practices. The Foundation President is compensated by a related organization which uses a market based compensation program utilizing several independent third party compensation market surveys to establish pay ranges for the position.
