The employee was immediately terminated and the Foundation is pursuing all legal means to recover the remaining funds. The fraud, which entailed falsifying vendor invoices related to employee allowances, inflating their value and then personally retaining the excess amount, was discovered by accounting staff in the Washington, DC office and was thoroughly investigated by the Foundations Certified Fraud Examiner and Senior Fraud Investigation Team. Immediately after the discovery and investigation of the malfeasance, the Foundation bolstered internal controls to include independent verification of the costs of the services rendered to international assignees and by compelling all international assignees to allow the Foundation to independently contact all service providers for which the assignee receives reimbursement.

DOCUMENTATION SUPPORTING COMPENSATION DECISIONS IS MAINTAINED BY THE FOUNDATION'S VICE PRESIDENT OF HUMAN RESOURCES AND ADMINISTRATION.
