Molecular Oncology The Department of Molecular Oncology (MO) is a large research program at JWCI (22 members including 3 Assistant Professors) The Molecular Oncology program is internationally recognized because of multiple discoveries particularly in the field of molecular biomarkers The program has been funded through federal grants, philanthropy and foundations The major focus is on solid tumors including melanoma, breast, brain, and gastrointestinal cancers In recent years emphasis has been on molecular prognostic/diagnostic biomarkers and epigenetics regulatory and therapeutic targets Some of the major pioneering studies accredited to the department address the prognostic utility in cancer patients (phase II and III clinical trials) of circulating tumor cells (CTC) and circulating DNA (genomic, mutation, methylation), the molecular staging of sentinel lymph nodes and epigenetics The department recently received funding from the NIH TCGA program in several types of solid tumors for genomic, methylation, and RNA sequencing These translational research efforts have been conducted through close collaboration between JWCI oncologists and other centers The MO department has collected well annotated blood and tumor specimens for molecular studies from over 75 centers around the world and has significant experience in large scale phase II and III studies The department therefore offers a well-organized research program that can offer collaborative support to the Providence Health System and intellectual property development The Department of MO trains on average 10 research postdoctoral fellows per year and has a strong history of training foreign surgical oncology MD and MD/PhD fellows (>60) from major elite universities in Japan,(Tokyo, Keio, Osaka), the Netherlands (Leiden University), and China (Fudan University, Huashan) Gene Sequencing Center The gene sequencing center was established at the JWCI in December 2013 Using state of the art equipment the center can perform any potentially useful type of gene sequencing, including whole genome sequencing To date, over 200 tumors have been sequenced A major project underway that has taken advantage of the unique melanoma tumor repository is whole genome sequencing on paired melanoma tumors and lymphocytes The formidable requirements for data storage, data transfer and bioinformatics are provided through contracts with the national lambda railroad (NLR, NantWorks) a high speed (40Tb/sec) network connecting JWCI to other cancer institutes Funding for the sequencing center is provided by major corporate grants

Form 990, Part III, Line 4b:

Melanoma Research JWCI has one the largest melanoma programs in the world. Research has involved international multicenter clinical trials, industry sponsored clinical trials, and basic science research. Results of these studies have been published in numerous peer-review journals including the New England Journal of Medicine. There are ongoing potentially practice-changing clinical trials in melanoma. Basic science research includes genomics, translational immunology and the development of novel immunotherapies.

Form 990, Part III, Line 4c:

The Department of Translational Neuro-Oncology and Neurotherapeutics (TNON) was established at JWCi in August 2015. TNON's research areas include discovery and development of novel drug candidates for clinically validated molecular targets, biomarker-based drug development for precision medicine, nanotechnology-based approaches to deliver drugs across the blood brain barrier, new immunological approaches to diagnose and treat cancer and CNS diseases, and integrated information technology, big data and novel biosensor/device development. This is accomplished through basic science research, preclinical research, translational research, and clinical research. TNON's basic science research explores specific aspects of how brain cancer initiates and progresses. Active initiatives include tumor cell metabolism, molecular signaling pathways and nanotechnology in drug delivery. TNON's preclinical research evaluates discoveries from basic research in preclinical animal models. Patient derived xenograft (PDX) and orthotopic animal models are employed for testing of novel therapeutic agents targeting brain tumors. A major focus is evaluating targeted therapies (small molecules/biologics) and immunotherapies as a single or combination dose with standard of care. TNON's translational research initiatives include Computational modeling and network pharmacology, biomarker development, genomics-proteomics, cancer stem cells, and immunotherapy. TNON's clinical research combines clinical expertise with leading-edge research to gain an in-depth understanding of each patient's individual tumor. Clinical trials offer more treatment options to eligible patients.

Surgical Oncology Fellowship Training Program and Other Research Programs Surgical Oncology Fellowship Program - JWCI has a long history of training leading clinicians, researchers and educators through its fellowship training programs. Graduates of these programs are currently in leadership positions at leading academic medical centers throughout the country. Only in extenuating circumstances is housing extended beyond this six month period. During 2016, there was 1 Officer receiving relocation/housing program payments. Providence also maintains a network of community ministry boards with responsibility for quality of care oversight, community relations, advocacy and community needs assessments. Salaries for senior executives are reviewed by the Providence St. Joseph Health Committee and approved by the full Board of Directors, none of whom is a Providence employee. The Board retains an independent consultant each year to review salaries of those in the most significant leadership roles in the organization. Part of the consultant's role is to review an extensive array of compensation surveys of large, not-for-profit health care systems in the United States. Providence is one of the larger health systems in the country, and as such, the Board benchmarks executive compensation against other large, not-for-profit health systems whose revenue is similar to that of Providence. Additionally, Providence's labor market continues to spread across health care and into general industry. Because of this, Providence also takes into consideration general industry for-profit market data, where applicable. Base salaries for Providence executives are generally targeted to the median level of the market, as identified by the independent consultant and reviewed with the Executive Compensation Committee. Performance incentives allow executives to earn additional compensation if they achieve specific organizational goals for furthering Providence operating commitments and strategic objectives. The Board of Directors conducts a thorough process to ensure performance incentives are aligned with appropriate market practices. The Board's process for executive compensation fully complies with IRS standards and mirrors best practices.</p>
