 SOAR Orphanage Project In 2016, the Evergreen SOAR (Special needs, Orphaned, or Abandoned children's Resources) project continued to aim to see the end of abandonment in Shanxi province and to care for those precious children who have been abandoned. In 2016, Evergreen continued its partnership with the local orphanage providing tailored, specialized care for 54 children (16 girls and 38 boys) with intellectual and/or physical disabilities. The SOAR program also continues to facilitate regular consultations with physical therapists, occupational therapists and speech therapists who coordinate and revise each child's Personalized Care Plan and train the caregivers in how to implement those plans. Note that expenses decreased in 2016 due in part to the local orphanage, per an agreement with Evergreen, underwriting a portion of the expenses, increasing in proportion over the next 3 years.

4b (Code) (Expenses \$ 160,002 including grants of \$ 0) (Revenue \$ 12,620)
 Joy in the Journey Camp Provides educational service to school-aged youth between 5th and 12th grades in an environment saturated with the love of Christ. Education is not limited to English only, but also the Life Education curriculum for healthy living, as well as various challenges designed to increase students' ability to apply creativity to new situations, work as a team, and discover leadership skills.

4c (Code) (Expenses \$ 47,800 including grants of \$) (Revenue \$ 189)
 In 2016, the Yuci Evergreen staff provided various services, e.g., surveyed people for various studies, conducted home visits, and administered physicals, to a total of over 9,000 individuals. In addition, the staff provided over 3,100 person-hours of health education for community members, including managing chronic diseases for individuals and conducting medical training.

 Yangqu Regional Economic Development (RED) Project In 2016, the Yangqu regions Bookmobile, Community Center and RED project were consolidated under RED. The number of library books in the community continue to exceed 12,000. The calligraphy, arts and crafts, and early childhood education classes with a focus on encouraging the student, and offering interactive western teaching methods served over 250 students. The bookmobile impacted again over 1,500 students and teachers monthly throughout Yangqu and Taiyuan (2 village schools).

 Evergreen Cards Ltd. During the just-completed year 2016 Evergreen Cards Ltd. provided job skill training and supplemental income to more than 25 poor rural households in Yangqu County. Net profit for the year (after payment of all Chinese taxes and Social Insurance Benefit payments) was U.S. \$2,706.00.
