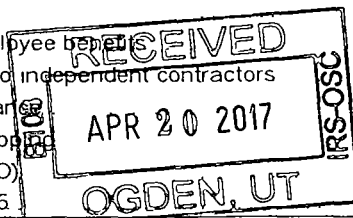



IN THOSE REPORTING YEARS THE ORGANIZATION'S LOBBYING EXPENSES WERE INSUBSTANTIAL DOLLARS-WISE. FOR EXAMPLE IN FISCAL YEAR JUNE 30, 15 TOTAL EXPENDITURES FOR "EAST BAY" WERE \$21,710,959. IN THAT SAME YEAR TOTAL LOBBYING EXPENSES REPORTED ON SCHEDULE C FORM 990 WAS \$108,588. THIS IS LESS THAN .5%.

THE ORGANIZATION EXISTS PRIMARILY TO REPRESENT 48 AFFILIATES IN EDUCATIONAL AND SUPPORT ACTIVITIES AND ALSO INCLUDE LOBBYING ACTIVITIES WITH A SMALL PORTION OF THOSE REPORTABLE ON SCHEDULE C. THE ALTERNATIVE WOULD BE FOR EACH OF THE 48 AFFILIATES TO HAVE THE LOBBYING ACTIVITIES ON THEIR BOOKS.
