Adara's focus is on improving health and education for women, children and communities living in poverty. We are experts in maternal, infant and child health, remote and rural community development, and the care, support and reintegration of children at risk. We also aim to change the way people think about the role of business in the world and the power of business/non-profit partnerships as well as share our expertise and experience to achieve greater impact.

Research and knowledge sharing focused on Kiwoko Hospital, in the Nakaseke District of Uganda. Undertaking baseline research in the area around Kiwoko Hospital to understand health needs. Monitoring and evaluating existing programmes.

4b (Code) (Expenses \$ 138,971 including grants of \$ 0) (Revenue \$ 0)
Medical advisory at Kiwoko Hospital, Uganda. Building capacity and providing international medical advisory services. Facilitating visits of expert medical volunteers to the hospital. Planning research and clinical programmes with the University of Washington and Seattle Children's Hospital.

4c (Code) (Expenses \$ 92,874 including grants of \$ 92,874) (Revenue \$ 0)
Medical equipment and program support at Kiwoko Hospital, Uganda. Providing medical equipment and supplies for the neonatal intensive care unit and maternal health department, and funding community based health care programmes. Assisting in project planning, implementation, capacity building, monitoring and evaluation.

(Code) (Expenses \$ 63,475 including grants of \$ 63,475) (Revenue \$ 0)
Adara Development (Nepal) - Adara Kids. Care and full support of 136 children who were previously trafficked and are now cared for by Adara Development (Nepal). Providing education, nutrition, health and post school options.

(Code) (Expenses \$ 17,016 including grants of \$ 17,016) (Revenue \$ 0)
Adara Development (Nepal) - Humla. Focus on two major programme components: community health (with an emphasis on mothers, infants and children) and education. Adara supports improving health services, to both address immediate community needs and implement long-term, sustainable strategies. Adara works with local village schools to improve the standard of education, provide them with much needed school supplies and help them to be more child-friendly. Adara provides assistance to children who would not normally be able to afford to go to school. By improving education in the district, Adara also hopes to eliminate the need for children to be sent away or trafficked to receive a quality education.

(Code) (Expenses \$ 10,240 including grants of \$ 10,240) (Revenue \$ 0)
Adara Development (Nepal) - project office. Project planning, implementation, capacity building, monitoring and evaluation of all Nepal partner organisations and projects. Assisting partner organisations with registration and compliance requirements and ensuring that all partners are exercising good governance.

(Code) (Expenses \$ 1,616 including grants of \$ 1,616) (Revenue \$ 0)
The Himalayan Innovative Society, Nepal. Raise awareness amongst the communities of Humla about child trafficking and the displacement of children from their families, communities and districts through an FM radio programme. Works with the children of single mothers who are oppressed in Nepali society, to make sure they receive an education. 62 children in single-parent families were supported with school fees, uniforms, stationery, bags and shoes, so they could attend school.

Himalayan Medical Foundation (HMF), Nepal. Adara supports HMF, a local NGO to provide free health care to people living in poverty on the outskirts of the city, including homeless people, monks, nuns, and other members of the community unable to afford to visit hospitals. In 2016, 12,209 people in Kathmandu received free medical treatment through the work of HMF.

Hands in Outreach (HIO). Adara supports staff and children's health costs of a local NGO that provides educational support to more than 140 children, primarily girls, at five schools around Kathmandu. These children live in very disadvantaged communities and would not otherwise attend school.

Providing relief assistance in the form of healthcare, food and housing materials after the Nepal Earthquake which occurred in April 2015.
