During 2016 PREF continued to sponsor programs related to its mission of nurturing peace within individuals and relationships, as well as promoting connectedness among groups in the larger community on Hawaii Island. The teaching and promotion of meditation as a practice leading to personal growth and transformation continued to be a major focus of PREF's activities. Thus in addition to continuing to sponsor a weekly program providing education on Contemplative Prayer, PREF also continued to sponsor periodic interfaith meditation programs, two programs introducing the Buddhist practice of "Tonglen, and a program entitled "Meditation: the Basics and Benefits." PREF also in 2016 continued with its interest in promoting personal health as a component of a peaceful lifestyle, hosting a program featuring Japan's Naoko Amano, a well-known musician and proponent of healing through exposure to the sound of the playing of crystal bowls. A second area of focus for PREF involves holding programs on days designated by the General Assembly of the United Nations as having particular significance. For example, the UN has designated September 21st of every year as the UN International Day of Peace, and June 21st as the International Day of Yoga. Similarly, the UN has designated the first week of February as Interfaith Harmony Week. Each of these designations is intended to promote the ideal and substance of peace and PREF sponsored in 2016 programs supportive of these goals. These included an Interfaith Breakfast February, a Yoga program on June 21st featuring yoga teachers from different traditions, and a Tonglen meditation program on September 21. Each of these programs represented Hawaii Island's participation in the global celebrations held under UN auspices. Recognizing that music is among the most peaceful of human activities, PREF also hosted at its Hawaiian Queen Coffee Garden venue concerts intended as fund-raisers for other community service-oriented, non-profit organizations. In 2016 this included such organizations as the Fukushima Kids Foundation and the Aloha Performing Arts Company. PREF also co-sponsored with the Kona Family Church the "Kona Thanksgiving Interfaith Concert", an annual event in which musical offerings by different faith communities provides opportunities for greater connection and understanding among all participants.
