The medical program provided Medical Care to approximately 1,800 patients which included 300 children in the city of El Catey, Dominican Republic in the surrounding community. We hosted one medical missionary team with volunteer medical providers. We have a Dominican national medical doctor volunteering in our medical clinic. She received a scholarship from a partner organization to complete additional training in exercise and nutrition and provided these services in addition to general medical care. The medical program continues to provide a scholarship for a local Dominican to attend dental school in Santo Domingo. He is scheduled to graduate in 2017. The sports and community outreach program hosted a Dominican church that used the facility for community evangelism each month. The sports program provided a scholarship for a Dominican national to attend professional umpire school in Daytona Beach Florida for the second time. The sports program hosted a mission team of four young men who organized and directed a summer baseball league for 40 youth in El catey.
