Over the past several years, Climate Foundation has observed the mass coral bleaching globally. The coral bleaching observed in Hawaii in 2015 was the worst bleaching event in the last half a century on Hawaii. Climate Foundation conducted planning meetings with the Honolulu SeaWater Air Conditioning corporation, planning the development of a reef cooling system for protecting coral reef from peak summer temperatures. This system will utilize the outfall temperatures of cool seawater without transferring nutrients. A successful demonstration of this infrastructure will pave the way to protect high-value reefs across the tropical oceans.
