FURTHERMORE, BREAST CANCER IS THE SECOND LEADING CAUSE OF CANCER-RELATED DEATHS AMONG WOMEN, WITH APPROXIMATELY 1 IN 8 U.S. WOMEN DEVELOPING INVASIVE BREAST CANCER AT SOME POINT IN THE LIVES. BECAUSE OF THE DEVASTATING IMPACT OF BREAST CANCER ON WOMEN AND THEIR FAMILIES, UBCF VIEWS THE PREVENTION AND CURE OF THIS DISEASE AS CRITICAL TO FURTHERING ITS MISSION.
