A Care Services team member meets a family upon diagnosis and discusses current and future needs for the patient. They are provided with necessary guidance and referrals, meeting them during their time of need. On going phone consultations enable our team to monitor each patient's progression, and needs, to provide education, supportive care decisions, and end-of-life planning. In FYE 2017, 618 individuals living with ALS and their families were served by the Chapter. Medical Equipment Loan Program provides mobility equipment and communication devices when insurance companies and other programs can not. Assistive medical equipment and communication devices are items that increase patient mobility and help them maintain a degree of independence as they lose muscle control. 90 ALS patients received loaned equipment in FYE 2017. Monthly Support Groups are where patients, family members, caregivers, and friends can share in the knowledge that they are not alone in their fight against ALS. Group meetings are held throughout the state of Georgia in Marietta, Macon, Athens, Fayetteville, Dalton, & metro-Atlanta. In FYE 2017, ten (10) monthly support groups were held a quarterly meeting for caregivers. 835 attendees (including ALS patients, caregivers and family members attended). Multidisciplinary ALS Clinics staffed by neurologists, speech and respiratory therapists, social workers and dietitians are an integral part of an ALS patient's medical care. Our Care Services staff are part of these clinic teams, as well as financially supported by the Chapter. Clinics are held at the Emory ALS Center, Georgia Regents University in Augusta & Macon. 532 ALS patients attended clinic in FYE 2017. ALS Education & Outreach programs seek to raise consciousness about ALS in order to ensure more people understand the disease and the special needs of ALS patients. Outreach efforts include in-service trainings to healthcare providers, including home health agencies, hospices, nursing homes, and local neurology practices and other organizations that are in need of ALS education. Our annual Educational Symposium targets ALS patients, families, caregivers and the general public in an effort to provide current and relevant knowledge about living with ALS. Public Policy focused to raise awareness, advocate for issues, and seek funding for ALS patients and their families at the state level and nationally. An annual Georgia ALS Advocacy Day is held at the Georgia State Capitol with ALS patients and family members attending, visiting with Georgia legislators. An annual ALS Public Policy Conference is
