Other programs include a diverse slate of mini-festivals rounding out the calendar year, including The Women+Film Festival, a six-day showcase of documentaries, narratives, and short films celebrating the best in women-centric programming, the CinemaQ Festival, the leading Colorado brand in LGBTQ film, CineLatino, a 4-day, cultural celebration of Latino Cinema and RSC Shorts, a celebration of the short film format. Also included in other programs is the DFS Young Filmmakers Workshops, developed for teens aged 12-18, the workshops furnish their participants with opportunities to learn the art of cinema, collaborate with other young filmmakers, refine their work with industry professionals and exhibit their films in public premieres.
