There are certain transactions that could be deemed "Unrelated Business Income" and would result in a tax liability. The Foundation recognizes the effect of income tax positions only if those positions are more likely than not to not be overturned upon examination by the applicable authorities. Management has reviewed the transactions to estimate potential tax liabilities. In accordance with Internal Revenue Code Section 6033(e), the Foundation has elected to pay all tax on lobbying expenses, rather than notifying its members that a portion of their dues is not deductible. The Foundation incurred taxes of approximately \$1,133,145 and \$1,228,019 on lobbying expenses of \$3,237,556 and \$3,508,625 during the years ended March 31, 2017 and 2016, respectively. Management annually reviews its tax provisions and has determined that there are no material uncertain tax positions that require recognition in the financial statements. The Foundation's federal returns for fiscal years after 2013 remain subject to examination by the Internal Revenue Service.
