Clementine Lockwood Peterson Foundation (the Trust) satisfies the Responsiveness Test, including both the "relationship" test and the "significant voice" test under Treas. The Trustees maintain a close and continuous working relationship with the Trustees of the Greenwich Library, and by reason of this relationship, the Library has a significant voice in the Trust's investment policies, the timing of grants, the manner of making grants and the use of its income and assets.

The Trust was established under Article EIGHTH of the Will of Clementine Lockwood Peterson for the benefit of The Greenwich Library, and requires the Trustees to distribute all or any part of the net income and principal at such time and in such manner as the Trustees in their sole discretion determine will best promote and advance the general uses and purposes of the Library, taking note of the testatrix's preference that trust distributions be used for the Business Section and the Recorded Music Department to the extent that the Library has a reasonable use for funds for these purposes.

Working with the Library, the Trustees adopted as the Trust's mission the creation and support of a new wing of the Greenwich Library to house the Library's Business Section and Recorded Music Department. The Trust funded the purchase of land and the construction of a new wing of the Library in the 1990's to house the Library's Business Section and Recorded Music Department. The Trustees make annual distributions that fund all of the wing's maintenance and operating expenses. Traditionally, the Trustees have made annual distributions in an amount equal to 4.5% of the average annual fair market value of

the Trust's assets for its three immediately preceding tax years. At the Library's request, the Trustees established a sinking fund within the Trust to fund capital repairs to the wing. The sinking fund (approximately 10% of the Trust's assets) is excluded in calculating the annual distribution amount. Also at the request of the Library, which operates on a June 30 fiscal year, the distribution was changed to a June 30 annual distribution, and the average annual value of the assets is determined using June 30 fiscal year values.

The Trustees send monthly investment statements to the Library for review and communicate with Library officials in person or by telephone as needs arise for a distribution from the sinking fund and whenever representatives of the Library wish to speak with a representative of the Trust.

Each year, the Trustees provide the Library with a copy of the trust's annual return, an annual accounting, and a letter showing the calculation of the support to be provided for the coming year -- as well as the required annual notification (describing the type and amount of support provided during the prior year).

Each year, the Trustees meet in person with the Library's Board of Trustees, officers and the wing librarians to review the Trust's administration, investment performance and distributions, and the Library's needs. The Business and Music Services librarians report on their programs and program needs. The Trustees report on the amount available for distribution from the Trust for the wing's maintenance and operations, as determined using an endowment-type formula designed to provide for the short- and long-term needs of the Business and Music wing. performance, and the Trust's investment managers make presentations and respond to questions from the Library's Board of Trustee regarding asset allocation strategy and investments. The Library's director presents the Town's budget for the Library and the budget proposed for the wing, and the Trustees vote on the wing's budget. Minutes are kept of the annual meetings.

The Greenwich Library is the supported organization listed in Part I, Line 11g, column (i), to which the Trust is responsive and which is attentive to the Trust.

All of the Trusts's distributions are made to the Library for its Business and Music Wing. As described above, the Trust's relationship with the Library and the Library's significant voice in the Trust's operations satisfy the "responsiveness test."

The Trust's distributions to the Library are more than sufficient to ensure its continuing attentiveness. When the Trust was created, the Trustees adopted the Library's Business Section and Recorded Music Section as the Trusts's mission. The Trustees expended approximately two-thirds of the original assets of the Trust to fund the Library's purchase of land and construction of a new Business and Music Wing to house those operations. The Trust's annual distributions fund all of the Business and Music Wing's maintenance and operating expenses, as well as capital repairs to the Wing, and the Trust's distributions are a major factor in determining the Library's budget for the Wing. Historically, the amount distributed by the Trust has represented from 25% to 80% of the Library's total annual support.
