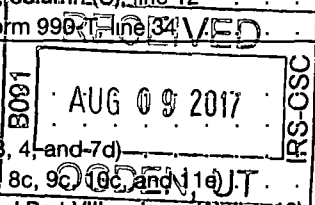

Three Strand Cord weaves together sustainable communities built on a strong Biblical foundation. Three Strand Cord equips these communities by setting into motion seven spokes of independence: clean water, renewable food, appropriate education, available medical care, a viable economy, reliable power and Biblical discipleship. Three Strand Cord also partners with growing organizations and mission teams who can benefit from the experience and resources available through Three Strand Cord.

OASIS PROJECT: 3SC partners with local communities in international locations to secure seven basic elements of self-sufficiency: clean water, renewable food sources, available medical care, appropriate education, a viable economy, and Biblical discipleship. In 2016, 3SC finished the installation of a water machine which produces enough clean water to provide for the water needs of 5,000 people per day in partnership with one of the schools in our scholarship program. Additionally, 3SC provided over 50 scholarships at three selected schools. 3SC also aided in hurricane recovery providing materials to rebuild a school building, repair a community water system and begin an agricultural project. 3SC also provided 10 microloans to help stimulate the economy in these communities as well as to aid farmers to increase production after hurricane damage.

4b (Code: ) (Expenses \$ 30,698 including grants of \$ 7,517 ) (Revenue \$ )  
SHORT TERM TRIP SUPPORT: 3SC supports churches within the United States who have long assisted international communities by sending short-term mission teams to accomplish specific goals. Through these teams, the communities can access resources, knowledge, and man-power previously unavailable to them. Often, the members of these short-term mission teams make connections that grow into larger commitments; in fact, 3SC has seen numerous groups begin to work toward Oasis Project goals that began with a short-term visit. 3SC aids these teams by collecting funds, allowing them to access resources, and coordinating in-country efforts. In 2016, 3SC partnered with three trips which provided medical treatment for nearly 2,000 patients, dental care for 700 patients, and veterinary care for 150 animals. These trips also included wellness education and project management including rebuilding of damaged school buildings.

SUPPORT of GROWING ORGANIZATIONS: Leveraging its administrative capabilities, 3SC helps organizations that need support to begin or enhance their capabilities, including accounting and reporting. 3SC currently supports organizations ranging from primarily humanitarian to primarily ministerial across the globe. In 2016, supported organizations included: Knapp Baptist Orphanage in Tanzania, Word of Life ministries in the United States, Sowing for Eternity in the Dominican Republic, and Ethnos360 training in the United States

The first, direct payment to the foreign organization, requires the completion of an expenditure agreement letter after successfully undertaking a pre-grant inquiry. After the money is distributed, contractors for Three Strand Cord collect the corresponding receipts and confirm that work was undertaken as expected. Reporting is then forwarded to the US-based staff and the Three Strand Cord board for review. Secondly, Three Strand Cord makes direct payments to organizations or vendors for needed supplies for teams accomplishing work. Similarly, the materials are delivered, and contractors for Three Strand Cord oversee their use to ensure the work is accomplished as prescribed. Finally, if necessary for the fulfillment of a program aim, money is transferred through an independent contractor overseeing, on behalf of Three Strand Cord, the work being done. After any of these expenditure methods are used, reporting must be submitted by all parties as to how the money or supplies were used in completion of the functional purpose. When possible, an officer of Three Strand Cord travels to review the completed work.
