The Maasai Stoves and Solar Project:

This projects works with the Maasai of northern Tanzania. With the women of the villages of Monduli Juu, the ICSEE has designed a wood stove which gets the smoke out of the houses, conserves wood, and lessens women's wood gathering labor. The local people are being assisted in all aspects of stove production. The ICSEE is assisting women to start businesses for income to buy stoves for their families. Women's teams are being organized and trained to install and maintain stoves.

Photo voltaic systems for light are being introduced to eliminate kerosene burning as the primary light source in the Maasai homes.

Water sanitation systems are being developed bringing safe chlorinated water to remote settlements and men are being helped to critically adapt their cattle management methods to changing climactic conditions.

Ways to help the Maasai spread these benefits to many villages are being developed.

There are organizations in Kenya, Uganda, and Rwanda working with the ICSEE since the stove being produced in Tanzania is suited to help solve health and conservation problems in these countries.
