Facts And Circumstances Test

The Maine Masonic Charitable Foundation of the Grand Lodge of Maine conducts charitable activities across the State. Much of this activity is in conjunction with 183 Masonic Lodges and 24 District Associations of Lodges. The Foundation actively encourages contributions from the lodges, their members, and the public. Bequests and legacy gifts are also encouraged. Although the Foundation is not a membership organization, the lodges are. Dues are reasonable and membership is available to all economic groups within Maine. There are approximately 17,500 members of the Masonic fraternity in the State, as well as non-Masonic members of the public, working with the Charitable Foundation to benefit their communities in various ways. The organization sponsors several programs intended to benefit the community as a whole. The Foundation provides funding, and Masons provide volunteer time. Non-Masons actively work alongside the Masons in implementing these programs. There are time tested programs that the Foundation supports and new, innovative programs that the Foundation has started in recent years to better serve the State of Maine. Our Bikes for Books program continues to expand by leaps and bounds across the State. The program is intended to be executed in concert with a school's reading initiative to support local schools. Each year, we have seen an increase in the number of lodges who are going into the community, reaching schools to propose a partnership, engage the community to raise funds, and see free bikes and helmets into the hands of worthy children who have earned a reward for their efforts. This past year we have seen thousands of bikes given away and our matching grants totals were up by 68% (FY 2016) and 38% (FY 2017) respectively over the last two fiscal years. School administrators, children, parents, and lodge members all know this program works and benefits their communities. In the 2016-2017 fiscal year, we had almost 90 lodge apply for matching grants resulting in thousands of children being rewarded for their hard work. The Foundation has also funded the purchase of helmets to go along with the bikes given out by the lodges and will spend about \$20,000 per year on free helmets to ensure the safety of the lucky winners. During the 2014-2015 fiscal year, the Foundation undertook a fundraising initiative to expand our Masonic library in Holden with great success resulting in ground breaking in the early part of the 2015-2016 fiscal year. The library expansion was greatly supported from around the state, and especially appreciated in Holden where they have no public library and the Foundation has opened the doors to the community and schools there. The project was highly successful and has resulted in amazing, wide ranging support. The library has been built and is frequented by Masons and the community alike. Pledges are still being received in the 2016-2017 fiscal year. The Foundation has a generous and robust Relief program, whereby a lodge may work with an individual or family to assist financially in times of need. The lodge will help to complete an application whereby the particular details of a situation are collected and examined. Relief money will be provided for a variety of causes, such as the renovation of a bathroom for handicapped access, assistance with medical bills after a long illness, providing heating oil during the winter months, and more. The intent of these relief dollars is to provide someone who has fallen on hard times a bit of respite. The Brotherhood Relief grant is less cumbersome to obtain, but also has a \$500 maximum grant amount. This relief grant is designed to be a speedy distribution to offset the pains of a larger problem. One of the first Brotherhood Relief grants given out was to a family who had lost their house in a fire. It enabled them to quickly purchase new clothes and food while insurance matters would address the rest of their needs. These relief dollars are for Masons and non-Masons alike. The Foundation has also asked the members of the Grand Lodge of Maine and its constituent lodges to support various relief programs in and out of the State of Maine. One of the more successful has been our support of the Wreaths Across America program. In the 2016-2017 fiscal year, we took in enough donations to purchase over 1,000 wreaths to be placed upon the graves of the Veterans of our country. 2016-2017 saw the start of the planned funding of the National Masonic Foundation for Children in the State of Maine. The first program to be offered is called The Masonic Model Student Assistance Program offers educators training on identifying children who may be at risk for substance abuse, depression, violence, and/or suicide within school settings. The Safe Schools Workshop helps schools learn prevention skills around bullying, anger, and conflict resolution. This highly respected and sought after program is for all school employees. We hope these courses will be available for schools across the state to further help protect and nurture the young people in our communities. Many states are thriving under the principals learned under these two programs and we hope to expand them around Maine. The Foundation provides direct financial support to the all six of the Maine Veteran Homes and the VA Hospital in Togus, the two Children's Dyslexia Centers in Maine, a Masonic museum and library in Holden, various scholarships, two Boy Scout troops in Maine, support for the Maine Masonic College, the MS Society, and Goodwill Incorporated's Veterans Assistance Program. The Foundation also provides direct charitable assistance to Masons and non-Masons on a demonstrated need basis. The Foundation also provides financial support for activities conducted by local lodges. During the past year, an additional 2,034 Masonic volunteers participated in local community events such as support for Project Graduation (89 Masonic volunteers, 373 Masonic hours, 161 non-Masonic volunteers, 500 non-Masonic volunteer hours), Bikes for Books (1076 volunteers Masonic volunteers, 4,852 Masonic hours, 1,338 non-Masonic volunteers, 6,446 non-Masonic volunteer hours), Youth Activities Programs (334 Masonic volunteers, 1,036 Masonic hours, 344 non-Masonic volunteers, 1,647 non-Masonic volunteer hours). Other community activities (535 Masonic volunteers, 2,535 Masonic hours, 960 non-Masonic volunteers, 4,081 non-Masonic volunteer hours). Because of the broad nature of its financial support and volunteer activity, because of the number and nature of the community activities it conducts and supports, and consistent expansion of the Foundation's beneficial programs, the Foundation believes there is no doubt that it meets the facts and circumstances test of IRC Section 509(a).
