Each year Good Samaritan Health Services Foundation hosts a Creations Auction and Dinner in support of Heart of America Hospice. The Tax year 2016 event raised \$22,474. Creations Auction proceeds and other Hospice contributions are held in a savings and an investment account managed by the Foundation. HAMC's interdisciplinary Hospice team provides ongoing medical, emotional and spiritual support for patients of all ages and their families. They provide care for individuals with terminal illnesses such as Alzheimer's, dementia, COPD, cancer, Parkinson's disease, ALS and AIDS. Memorials, donations and funds raised by the Foundation supplement insurance payments so families can focus on loved ones without worrying about finances. In Tax Year 2017, Heart of America Hospice provided 22 terminally ill patients with 1,027 days of service. The Hospice nursing staff made 2,632 visits (1 visit is equal to 15 minutes). The average monthly Hospice census was 4.2.

Form 990, Part III, Line 4b:

The Foundation hosts an annual Charity Golf Classic to raise money for specific projects in support of Heart of America Medical Center. In 2017 the golf tournament raised \$19,566 for a Cancer Care Patient Fund. The fund was established in 2017 in conjunction with the establishment of HAMC's infusion therapy suite. The state-of-the-art facility brings the latest treatments to patients, whether they have cancer, a chronic infection, an immune disorder or another condition that requires intravenous therapy. The HAMC Cancer Care Fund grant program is designed to lessen financial burdens for local cancer patients by providing financial assistance for medication, specialized treatments, travel, lodging, groceries, and other expenses not covered by insurance. Assistance is granted in the form of gift cards and vouchers or direct payments to vendors such as the hospital, clinic or utility companies. The infusion therapy suite took two years from concept to completion, with funding provided by the USDA, the Foundation, and HAMC.

Form 990, Part III, Line 4c:

A third major program supported by the Foundation is Walk For a Wish. This employee-focused program funds Heart of America Medical Center and Haaland Estates employees' requests for medical, office and training supplies or equipment that will improve patient care and employee working conditions and are not covered by department budgets. In July 2017, 32 employees and their families walked a two-mile course and were granted \$18,351.44 in wishes. Items purchased with the 32 Walk for Wish grants included a sedation stethoscope for the operating room, a video intercom system for the pharmacy, baby strollers for the HAMC daycare, CPR mannequins for Emergency Medical Services training, and an ice machine for the HAMC's clinic in Dunseith.
