Mercy Clinic provides health care to uninsured, underinsured adults living in central Fort Worth. The clinic is open two nights per week and is staffed entirely by volunteers. No charge is made to patients for services provided. In 2016, 1,646 unduplicated patients were served with 1,710 prescriptions filled on site for our patient population. Laboratory services are available both on site and in partnership with a local laboratory, both at no charge to the patient. Health education classes and counseling by a dietitian are conducted regularly. Effort is also made to meet emotional and spiritual needs of patients.

In the list of community needs among the low income uninsured population, dental care ranks high. The Mercy Clinic provides dental services five nights per month. Approximately twenty percent of all patients treated by Mercy Clinic are dental patients. These patients receive complete dental examinations with x-rays, a treatment plan, and follow up appointments for extractions, fillings, root canals, and basic hygiene. All dental care is provided without charge to the patients. The dental services are provided by volunteer dentists and assistants.

Mercy Clinic sponsors community health fairs twice per year. These health fairs address health education, provide back-to-school vaccinations, flu vaccines, mammograms and other health and safety initiatives. Since the inaugural fair in November 2013, these events have been attended by hundreds of children and adults. Attendance in FY17 exceeded 800.
