**Children and Youth Programs**  
ServeNow works with disadvantaged children and orphans, as well as street children, in centers located in some of the major slums in India and one in Kathmandu, Nepal. In some locations schools from Kindergarten to Grade 4 are in operation, in other areas children are taught to read and write, as well as taught life values through teaching, drama and music. Through special Vacation Bible School programs the children are taught lessons from the Bible. ServeNow also works with children in Ukraine, Nepal and Uganda through training programs, summer camps and school education.

**Scripture and Church Teaching Programs**  
One of the major projects of ServeNow is to assist local congregations in remote areas and in the slums, providing such churches with Bibles. Pastors are also trained in major themes of church teaching. ServeNow provides training materials for each member in these congregations on a long term basis. Individual training programs are also conducted in strategic locations in each country. The bulk of these resources and Bibles are published, printed and shipped through MediaServe, a division of ServeNow located in Europe.

**Humanitarian programs including containers**  
In areas where it gets freezing cold and children and elderly have no winter coverings, we provide winter clothing, in remote villages and in slums. ServeNow provides day medical camps, with national physicians and nurses, seeing approximately 150 patients a day. These camps take place on a monthly basis in a different location. In the summer when drinking water is scarce, clean water is provided during the worst months for individual families in remote communities, villages or slums. To train young women in a trade, in order to avoid being drawn into trafficking, ServeNow operated several six month tailoring schools as well as cosmetology schools schools and bakery classes. ServeNow also provides container loads of humanitarian aid such as medical equipment, clothing and furniture to the war-torn areas of Ukraine and also one to Panama. The short term teams provide additional needed staffing for a variety of humanitarian and other ministry programs. Teams allow individuals to have a life changing experience by spending time in international settings working alongside nationals providing winter clothing, assisting national doctors and nurses in medical camps, providing free drinking water, or taking part in summer camps for orphans, physically challenged and refugee children.

Current balance of payable is \$136,104.

ServeNow has chosen to partner with The Salvation Army Humanitarian Aid in Sweden to fulfill our mission statement around the world.

"Serving people in need by caring for orphans, widows, underprivileged children and youth by providing humanitarian assistance where needed." The Salvation Army Humanitarian Aid receives medical, handicap, and personal equipment from hospitals, community centers and companies. We have written agreements with counties, communities and private companies regarding their equipment. When we receive different items, the hospital establishes the price for each piece of equipment. Depending on its prior use, we discount those prices up to 40%. There are stringent rules regarding comfort, standard and durability, both from EU and Swedish authorities. All items received and then passed on to ServeNow are cleaned, renovated and in full working condition. Medical machines, etc., are checked by technicians from the donating hospital. As an extra control, we value each major piece of equipment, with matching age, from other groups like Ebay.

This support allows the national leaders to hire competent national staff which, thereby, also supports the local community in these countries.
