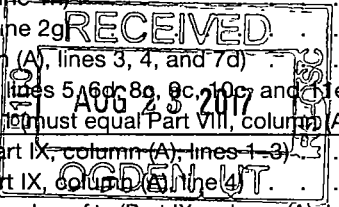

Direct Customer Services. EOF receives grant funding, primarily from the federal Community Services Block Grant (CSBG) to provide direct services to eligible low-income customers. Services provided during the agency's 2016 fiscal year include: 1) Emergency Assistance - which helps families obtain needed supports, such as utility and rent assistance and mortgage default counseling, to address emergency situations; 2) Employment Services - which helps unemployed individuals with job preparation and placement assistance; 3) Case Management Services - which helps low-income families work on economic self-sufficiency and goal achievement; 4) Senior Commodity Distribution - which provided food assistance to elderly and disabled individuals; and 4) Housing Services - which helps low-income individuals address current homelessness or help those at risk of becoming homeless. During the 2016 fiscal year, EOF assisted 512 individuals from 211 families with one or more of these services.
