State Engagement Many state partners are following Recommendations and Strategic Tools for Effective Angler Recruitment, Retention and Reactivation, a new playbook for assessing and improving current R3 tactics and developing effective new ones. Built upon previous Wildlife Management Institute efforts, the resource was developed in partnership with the Aquatic Resources Education Association with support from the Angler R3 State Agency Working Group. The Annual State Marketing Workshop, Charting the Course for Future Success, held in Atlanta, Georgia, attracted the highest attendance of any State Marketing Workshop to-date. More than 150 attendees, including 11 state agency directors, learned about R3 marketing and customer service, and about state R3 pilot programs. During the Workshop, RBFF provided each state with its own suggested 60 in 60 goal for annual license sales. The year's webinar series also helped grow state partners' marketing capacity. Webinars focused on digital engagement, angler R3 efforts, leveraging RBFF's national media plan, and outreach to the Hispanic community. FY17's annual state marketing programs together yielded unprecedented results. The boat registration reactivation program alone resulted in more than 51,000 boat registrations and generated the highest revenue to date, almost \$2.0 million, for the 18 participating state agencies. Successful RBFF-powered pilot programs included a Georgia angler retention program that resulted in more than \$92,000 in revenue. The program led to production of the First-Time Buyers Retention Email Campaign Toolkit, available free to all state partners. Georgia also utilized RBFF's Reactivation Toolkit, developed in FY17, to reach lapsed anglers via email. The reactivation program generated more than \$171,000. To spur additional innovation, RBFF awarded its second year of State Innovative R3 Program Grants. Grants funded development of a new mobile fishing app in Colorado, efforts to increase high school participation in fishing teams and clubs in Florida, enhancement of Georgia's outdoor map, a fishing promotional campaign in Iowa in collaboration with the state tourism agency, and a program for tracking and engaging anglers at events in Nebraska.

Form 990, Part III, Line 4c:

Industry Engagement Increased participation in boating and fishing is a bulwark against a changing consumer environment. The more boaters and anglers out there, the greater the demand for industry products. In FY17, RBFF's Take Me Fishing-branded R3 activities increased participation. RBFF also instituted initiatives to help industry partners themselves reach and engage new customers. RBFF funded the Recreational Boating Leadership Council's (RBLC) production of actionable R3 training modules, including a video on how to incorporate multicultural messaging in marketing. The video features West Marine's experience in formulating a more inclusive marketing campaign. Another video highlights Freedom Boat Club's efforts to engage Hispanics, using RBFF free materials and guidance to execute it. Nationwide events and engagement. During National Fishing and Boating Week, RBFF teamed with SouthBend and Fishing League Worldwide (FLW) to hold #ReelFun fishing events at more than 1,000 Walmart stores. Public relations outreach related to the fishing events produced 31 million media impressions. SouthBend and FLW's partnership with RBFF is ongoing, and designed to engage event attendees year-round. Another continuing partnership -- with Discover Boating -- remains strong. This year, it resulted in 123,030 consumer referrals from TakeMeFishing.org properties to DiscoverBoating.com. More industry support for the George H.W. Bush Vamos A Pescar Education Fund. The business community's donations to the Fund continued, together furthering programs that foster a love of boating and fishing among Hispanic families. In FY17, The Walt Disney Company added to its previous support of the Education Fund, as did Bass Pro Shops with a donation of \$50,000. Cabela's Outdoor Fund generously provided a \$75,000 grant.
