The Read2Succeed program recruits volunteers 18 years of age and older who will tutor students for at least an hour a week. AARP Foundation Experience Corps finds mentors 50 years of age and older to tutor those students in reading. The UWCG prepares at-risk pre-school children and young students through First Steps and Parents as Teachers initiatives.
