In October 2000, following the merger of Christian Financial Concepts, Inc. and Crown Ministries, Inc., the Board of Directors of the merged organization of Crown Financial Ministries, Inc. endorsed the agreement. These rights include the revocable rights to purchase, use and modify all copyrighted materials produced by the founder. Crown also purchased the exclusive rights to the publicity of Larry Burkett's image and name as part of its continuing ministry. In exchange for these rights, Crown provides an annual payment, of \$75,000 along with certain medical benefits (both indexed to inflation), to the co-founder's surviving spouse. Every three years the agreement requires a formal review of the actuarial calculation of the amount projected to meet all future payments. During 2017, management, along with the assistance of an independent third-party actuary assessed these assumptions and inputs and determined that, due to changes in the RP-2000 female mortality table, with no projection, resulting in an increased life expectancy of the co-founder's surviving spouse, the future liability should be increased as of March 31, 2017, resulting in a \$79,945 adjustment to increase the licensing agreement liability in the accompanying statement of financial position. Assumptions used in the calculation of the liability include a discount rate of 6% and an assumed cost of living increase for expenses other than medical of 2.25%. There was no cash flow impact from this adjustment for the year ending March 31, 2017. Future annual estimated cash flow impact resulting from these updated projections is not expected to be significant. The present value of these benefits was estimated to be \$967,106 and \$1,016,386 at March 31, 2017 and 2016, respectively.
