COMMUNITY BUILDINGWE ACCOMPLISH OUR RESULTS BY BRINGING PEOPLE TOGETHER - SUBJECT EXPERTS, BUSINESS LEADERS, DONORS, NEIGHBORHOODS AND MEMBERS OF LOCAL NONPROFIT AGENCIES - TO HELP IDENTIFY OUR COMMUNITY'S MOST CRITICAL SOCIAL ISSUES. IN FORMING THESE PARTNERSHIPS, WE ARE BETTER ABLE TO ADDRESS THE UNDERLYING CAUSES OF PROBLEMS IN OUR COMMUNITY AND PREVENT THEM FROM HAPPENING. EXPENSES \$96,969 EDUCATION ORGANIZING AGENCY FOR PASO DEL NORTE HEALTH FOUNDATION'S IGNITE INITIATIVE WITH FUNDING FROM THE PASO DEL NORTE HEALTH FOUNDATION, UNITED WAY SERVED AS THE ORGANIZING AGENCY FOR THE FOUNDATION'S IGNITE INITIATIVE. THE INITIATIVE IS FOCUSED ON ENGAGING DISCONNECTED YOUTH IN HIGH-QUALITY OUT-OF-SCHOOL PROGRAMS ACROSS EL PASO AND HUDSPETH COUNTIES IN TEXAS, DO ANA, LUNA AND OTERO COUNTIES IN SOUTHERN NEW MEXICO, AND CIUDAD JUAREZ, MEXICO. DISCONNECTED YOUTH ARE DEFINED AS PEOPLE BETWEEN THE AGES OF 7 AND 18 YEARS OLD WHO ARE NOT INVOLVED IN OUT-OF-SCHOOL ACTIVITIES OR PARTICIPATING IN THE LABOR MARKET (PASO DEL NORTE HEALTH FOUNDATION DEFINITION, 2013). THE BORDERLAND OUT-OF-SCHOOL TIME (BOOST) NETWORK, LED BY OUR UNITED WAY, AIMS TO COORDINATE EFFORTS AND RESOURCES ACROSS THE OUT-OF-SCHOOL TIME (OST) FIELD TO INCREASE YOUTH ENGAGEMENT IN HIGH QUALITY PROGRAMS OPERATING IN SOUTHERN NEW MEXICO, WEST TEXAS AND CIUDAD JUAREZ, MEXICO. IN ITS FIRST YEAR, THE NETWORK HAS SUPPORTED COLLABORATION, COORDINATION AND COMMUNICATION AMONG OST PROGRAM PROVIDERS, OTHER YOUTH SERVICE AGENCIES AND COMMUNITY STAKEHOLDERS ACROSS THE PASO DEL NORTE REGION. EXPENSES \$136,260 KIDS' WAY THIS LONG-RUNNING PROGRAM, WHICH IS A PARTNERSHIP WITH REGION 19 HEAD START, PROMOTES COMMUNITY ENGAGEMENT AND PHILANTHROPY WITH CHILDREN AND THEIR FAMILIES. LAST YEAR, STUDENTS AND TEACHERS CREATIVELY FUNDRAISED \$8,000 FOR THE KIDS' WAY FUND. IN THE END, A TOTAL OF \$30,000 WHICH INCLUDED COMMUNITY IMPACT DOLLARS, FUNDED MINI-GRANTS TO PROGRAMS THAT DIRECTLY IMPACT CHILDREN AND YOUTH. EXPENSES \$30,000 3RD GRADE READING INITIATIVE FUNDED IN PART BY A GRANT FROM WELLS FARGO, OUR UNITED WAY PROVIDES YEAR-ROUND BOOK DISTRIBUTIONS-SUCH AS OUR SHARE THE LOVE OF READING, WHICH INCLUDED STORY TIME AND THEMED ACTIVITIES, AND PARTNERING WITH LOCAL SUMMER FEEDING PROGRAMS. UNITED WAY AND OUR PARTNERS ARE COMMITTED TO FOSTERING A LOVE OF READING AND BUILDING THE PERSONAL LIBRARIES OF EL PASO CHILDREN. EXPENSES \$16,636 BASIC NEEDS ENROLL EL PASO COALITION FOR THE FOURTH YEAR, THE ENROLL EL PASO COALITION WORKED TO HELP INDIVIDUALS SELECT A PLAN OR AUTOMATICALLY RE-ENROLL IN QUALITY, AFFORDABLE COVERAGE THROUGH THE HEALTH INSURANCE MARKET-PLACE. THE WORK OF THE ENROLL EL PASO COALITION, LED BY UWPC, CONTINUES GARNERING PRAISE FROM THE DEPARTMENT OF HEALTH AND HUMAN SERVICES AND THE WHITE HOUSE. MANY THANKS TO COALITION MEMBERS: CENTRO SAN VICENTE, COGNOSANTE, OFFICE OF COUNTY JUDGE VERONICA ESCOBAR, ENROLL AMERICA, LAS PALMAS DEL SOL HEALTH-CARE, OFFICE OF CONGRESSMAN BETO O'ROURKE, OFFICE OF SENATOR JOS RODRIGUEZ, PASO DEL NORTE HEALTH FOUNDATION, PROJECT AMISTAD, PROJECT VIDA, SMALL BUSINESS ADMINISTRATION, THE HOSPITALS OF PROVIDENCE, UNIVERSITY MEDICAL CENTER OF EL PASO, AND WORKFORCE SOLUTIONS BORDERPLEX. EXPENSES \$2,545 EFSP - EMERGENCY FOOD AND SHELTER PROGRAM UNITED WAY OF EL PASO COUNTY ADMINISTERS FUNDS FOR THE EFSP WITH MONEY PROVIDED BY THE U.S. DEPARTMENT OF HOMELAND SECURITY'S EMERGENCY AGENCY (FEMA). WITH SUCH A RESPONSIBILITY, UWPC BRINGS TOGETHER DESIGNATED REPRESENTATIVES FROM THE CITY, COUNTY, LABOR ORGANIZATIONS, TRIBAL GOVERNMENT, CHURCH ORGANIZATIONS AND LOCAL AGENCIES TO SERVE ON A BOARD THAT ALLOCATES THE FUNDING THROUGH A COLLABORATIVE EFFORT. THE GOAL IS TO HELP PEOPLE IN NEED OF EMERGENCY ASSISTANCE. THIS YEAR EL PASO WAS AWARDED \$314,305 LOCAL RECIPIENT ORGANIZATIONS' CENTER AGAINST SEXUAL & FAMILY VIOLENCE, EL PASO COUNTY GENERAL ASSISTANCE, EL PASO'S FIGHTING HUNGER FOOD BANK, EL PASO HUMAN SERVICES, OPPORTUNITY CENTER FOR THE HOMELESS/SIN FRONTERAS, AND THE SALVATION ARMY OF EL PASO COUNTY. EXPENSES \$3,523 INCOME FREE TAXES AND VOLUNTEER INCOME TAX ASSISTANCE. UNITED WAY HAS HELPED MORE PEOPLE KEEP THEIR HARD-EARNED MONEY WITH THE FREE SELF-PREPARATION TOOL, MYFREETAXES.COM. THROUGH THE EASY AND SAFE ONLINE TOOL, 310 FAMILIES AND INDIVIDUALS E-FILED AND SAW AN AVERAGE REFUND OF \$2,404. AMONG THOSE RETURNS, 135 FAMILIES RECEIVED AN EARNED INCOME TAX CREDIT AVERAGING \$2,444. IN PARTNERSHIP WITH CANUTILLO ISD, THIS PAST TAX SEASON, UNITED WAY ALSO HELPED STUDENTS BECOME IRS CERTIFIED TAX PREPARERS TO HELP HOST SIX SATURDAYS WHERE FAMILIES COULD RECEIVE IN-PERSON MYFREETAXES ASSISTANCE. EXPENSES \$7,682 COMMUNITY ENGAGEMENT VOLUNTEER EL PASO ORGANIZED WAY'S MOBILE FRIENDLY WEBSITE CONNECTS A GROWING NUMBER OF ENGAGED EL PASOANS TO VOLUNTEER EFFORTS AT MORE THAN 350 DIFFERENT AGENCIES-FOCUSED ON EDUCATION, HEALTH, ADVOCACY, CULTURAL AND ENVIRONMENTAL SERVICES, AND MORE. WITH A BRAND NEW LOOK AND LOGO, VOLUNTEER EL PASO ORG IS ONE OF EL PASO'S TOP WAYS TO SEARCH HUNDREDS OF OPPORTUNITIES. EXPENSES \$8,978 YOUNG LEADERS SOCIETY (YLS) SINCE 2008, THE YOUNG LEADERS SOCIETY (YLS) HAS BEEN INFORMING, EMPOWERING AND ENGAGING YOUNG PROFESSIONALS WHO ARE LOOKING TO TAKE THEIR CAREERS TO THE NEXT LEVEL. THIS PAST YEAR, THANKS TO ITS ACTIVE ADVISORY BOARD, YLS HOSTED SEVERAL NETWORKING MIXERS, INCLUDING A HOLIDAY MIXER THAT LEAD TO THE DONATION OF AT LEAST 60 TOYS FOR THE CHILD CRISIS CENTER OF EL PASO. IN JULY, THE GROUP HOSTED "AN EVENING WITH EL PASO'S LEADERS," A CANDID AND HONEST CAREER DISCUSSION WITH LEADERS INCLUDING THE HONORABLE VERONICA ESCOBAR, CARLOS GALLINAR, FORMER DEPUTY DIRECTOR OF PLANNING FOR THE CITY OF EL PASO, MARY KIPP, EL PASO ELECTRIC CEO, AND MONICA VARGAS-MAHAR, THE HOSPITALS OF PROVIDENCE SIERRA CAMPUS CEO AND CHAIR-ELECT OF THE UNITED WAY OF EL PASO COUNTY BOARD OF DIRECTORS. EXPENSES \$12,245 RISE RECENTLY LAUNCHED, RISE IS EL PASO'S FIRST GROUP FOR MILLENNIALS WHO WANT TO GIVE BACK. THIS AFFINITY GROUP'S MO IS TO #GIVEBACKHANGOUT THROUGH EXPERIENCES FOCUSED ON VOLUNTEERING AND DISCOVERING THE COMPLEXITIES OF EL PASO, ALL WHILE MEETING NEW PEOPLE. IN JUST TWO EVENTS, RISE HAS ENGAGED NEARLY 100 YOUNG EL PASOANS. DURING ITS KICK-OFF AT LATER LATER, MORE THAN ONE HUNDRED BOOKS WERE COLLECTED FOR BOOKS ARE GEMS, A LOCAL NONPROFIT FOSTERING A LOVE OF READING IN OUR YOUTH. IN MARCH, SEVERAL MEMBERS JOINED FORMER STATE SENATOR ELIOT SHAPLEIGH IN BEAUTIFYING THE BOWIE GARDENS BY PLANTING, TURNING SOIL AND COMPOSTING. EACH SCHOOL LEAD A HEALTH COALITION, COMPRISED OF A SELECT GROUP OF STUDENTS, VOLUNTEERS, AND SCHOOL STAFF, WHO WORKED TOGETHER TO CREATE A SCHEDULE OF HEALTHY EATING AND ACTIVE LIVING RELATED ACTIVITIES FOR STUDENTS TO PARTICIPATE IN. ON GYSD EXPENSES \$2,138
