DURING FY2017, WE HAD A THREE-DAY CONFERENCE THAT PROVIDED A TOTAL OF 23.5 APPROVED CONTACT HOURS. PART OF THAT CONFERENCE INCLUDED 5 CONTACT HOURS OF NON-CANCER PAIN MANAGEMENT CONTINUING EDUCATION REQUIRED FOR ALL NPS WHO HOLD DEA REGISTRATION AND A NM CONTROLLED SUBSTANCE LICENSE. WE RECORDED THAT PORTION OF THE CONFERENCE FOR SEPARATE CE APPROVAL AS AND ENDURING CE ACTIVITY TO MAKE IT AVAILABLE FOR NPS WHO NEED THAT REQUIRED CE BUT WHO WERE UNABLE TO ATTEND THE CONFERENCE. WE ALSO HAD A ONE-DAY CONFERENCE IN NOVEMBER 2016, THAT PROVIDED 8 APPROVED CONTACT HOURS. WE ALSO COMPLETED AN EXTENSIVE UPDATE OF THE FORMULARY THAT WE PROVIDE FREE FOR MEMBERS AND FOR A NOMINAL FEE FOR NON MEMBERS. IN ADDITION, WE RESURRECTED OUR DORMANT NEWSLETTER IN EARLY 2017 TO KEEP NPS IN NEW MEXICO ABREAST OF IMPORTANT PROFESSIONAL, POLICY AND CLINICAL INFORMATION.
