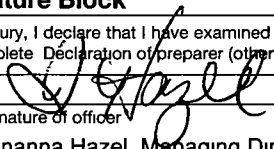

**Core programs: PAN North America is one of five regional centers worldwide. We link local and international consumer, labor, health, environment and agriculture groups into an international citizens' action network. Together, we challenge the global proliferation of pesticides, defend basic rights to health and environmental quality, and work to ensure the transition to a just and viable food system. In 2016-2017, our successes included 1) winning pesticide-free buffer zones around schools and daycare facilities in California, protecting tens of thousands of rural children; 2) increased responsiveness of state officials to Iowa farmers in the face of crop-damaging herbicide drift; 3) expanding the reach of the Equitable Food Initiative certification program to include farms employing more than 16,000 workers in the US, Mexico and Canada who will now be exposed to fewer dangerous pesticides; and 4) winning the strongest rules in the country protecting honey bees and other pollinators from pesticides in Minnesota.**

**Coalitions: PAN North America builds network power through strategic alliances with other public interest organizations. As the U.S.-based Regional Center of an international network, we facilitate collaboration among more than 150 organizations in North America, linked to some 600 groups in more than 90 countries worldwide. Often, our campaigns with network partners lead to creation of formal coalitions for which the Organization serves as facilitator, administrator and/or fiscal sponsor. The most significant coalition sponsored by PAN North America in 2016-2017 was Californians for Pesticide Reform (CPR). This vibrant coalition includes 185 groups across the state, among which PAN is one of the leading members in policy advocacy for children's health and farmworker protection. In the last year CPR and PAN have worked together to promote sustainable alternatives to fumigants; protect school children from pesticides applied to nearby fields; and promote sustainable agriculture in the San Joaquin Valley. PAN also supported coalitions and advocacy networks in Colorado, Hawai'i, Iowa and Minnesota.**
